- 5 SECTION 1. Subchapter A, Chapter 501, Occupations Code, is
- 6 amended by adding Section 501.0031 to read as follows:
- 7 Sec. 501.0031. REFUSAL BASED ON RELIGIOUS BELIEF. (a) In
- 8 this section, "psychological services" has the meaning assigned by
- 9 Section 501.003.
- 10 (b) A person who holds a license under this chapter may
- 11 refuse to provide a psychological service to a person if providing
- 12 the service would cause the license holder to violate a sincerely
- 13 <u>held religious belief.</u>
- 14 (c) A license holder who refuses to provide a psychological
- 15 service to a person under Subsection (b) shall coordinate a
- 16 referral of the person to a psychologist, marriage and family
- 17 therapist, licensed professional counselor, chemical dependency
- 18 counselor, or social worker, as appropriate, who agrees to provide
- 19 the counseling or therapy service.
- 20 (d) The board may not take disciplinary action against or
- 21 impose an administrative penalty on a license holder based on the
- 22 license holder's refusal to provide a psychological service under

- 19 <u>family therapy to a person under Subsection (a) shall coordinate a</u>
- 20 referral of the person to a psychologist, marriage and family
- 21 therapist, licensed professional counselor, chemical dependency
- 22 counselor, or social worker, as appropriate, who agrees to provide
- 23 the counseling or therapy service.

- 18 sincerely held religious belief.
- 19 (b) A licensed professional counselor who refuses to
- 20 provide a service to a person under Subsection (a) shall coordinate
- 21 <u>a referral of the person to a psychologist, marriage and family</u>
- 22 therapist, licensed professional counselor, chemical dependency
- 23 counselor, or social worker, as appropriate, who agrees to provide
- 24 the counseling or therapy service.
- 25 (c) The board may not take disciplinary action against or
- 26 <u>impose an administrative penalty on a licensed professional</u>
- 27 counselor based on the counselor's refusal to provide a service

- SECTION 4. Subchapter A, Chapter 504, Occupations Code, is
- 14 amended by adding Section 504.003 to read as follows:
- Sec. 504.003. REFUSAL BASED ON RELIGIOUS BELIEF. (a) A
- 16 person who holds a license, registration, or certification under
- 17 this chapter may refuse to provide chemical dependency counseling
- 18 to a person if providing the counseling would cause the holder to
- 19 violate a sincerely held religious belief.
- 20 (b) A license, registration, or certificate holder who
- 21 refuses to provide chemical dependency counseling to a person under
- 22 Subsection (a) shall coordinate a referral of the person to a
- 23 psychologist, marriage and family therapist, licensed professional
- 24 counselor, chemical dependency counselor, or social worker, as
- 25 appropriate, who agrees to provide the counseling or therapy
- 26 service.
- 27 (c) The department may not take disciplinary action against

- 1 or impose an administrative penalty on a person who holds a license,
- 2 registration, or certification based on the holder's refusal to
- 3 provide chemical dependency counseling under Subsection (a).

- SECTION 5. Subchapter A, Chapter 505, Occupations Code, is
- 18 amended by adding Section 505.0026 to read as follows:
- 19 Sec. 505.0026. REFUSAL BASED ON RELIGIOUS BELIEF. (a) A
- 20 social worker may refuse to provide a service within the practice of
- 21 social work to a person if providing the service would cause the
- 22 social worker to violate a sincerely held religious belief.
- 23 (b) A social worker who refuses to provide a service to a
- 24 person under Subsection (a) shall coordinate a referral of the
- 25 person to a psychologist, marriage and family therapist, licensed
- 26 professional counselor, chemical dependency counselor, or social
- 27 worker, as appropriate, who agrees to provide the counseling or

- 1 therapy service.
- 2 (c) The board may not take disciplinary action against or
- 3 impose an administrative penalty on a social worker based on the
- 4 social worker's refusal to provide a service under Subsection (a).
- 5 (d) A person may not bring a cause of action against a social
- 6 worker based on the social worker's refusal to provide a service
- 7 under Subsection (a).
- 8 (e) This state or a political subdivision of this state may
- 9 not penalize or withhold benefits, including tax exemptions,
- 10 governmental contracts, or grants, from a social worker based on
- 11 the social worker's refusal to provide a service under Subsection
- 12 (a).
- 13 (f) A social worker's refusal to provide a service under
- 14 Subsection (a) is not conduct that constitutes an element of a
- 15 <u>criminal offense.</u>
- 16 SECTION 6. The change in law made by this Act applies only
- 17 to conduct that occurs on or after the effective date of this Act.
- 18 Conduct that occurs before the effective date of this Act is
- 19 governed by the law in effect on the date the conduct occurred, and
- 20 the former law is continued in effect for that purpose.
- 21 SECTION 7. This Act takes effect September 1, 2017.
