- 3 open education resource instructional materials, and the State
- 4 Board of Education long-range technology plan.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 31.001, Education Code, is amended to
- 7 read as follows:
- 8 Sec. 31.001. FREE INSTRUCTIONAL MATERIALS. Instructional
- 9 materials selected for use in the public schools shall be furnished
- 10 without cost to the students attending those schools. Except as
- 11 provided by Section 31.104(d), a school district may not charge a
- 12 student for instructional material or technological equipment
- 13 purchased by the district with the district's instructional
- 14 materials and technology allotment.
- SECTION 2. Sections 31.002(1) and (1-a), Education Code,
- 16 are amended to read as follows:
- 17 (1) "Instructional material" means content that
- 18 conveys the essential knowledge and skills of a subject in the
- 19 public school curriculum through a medium or a combination of media
- 20 for conveying information to a student. The term includes a book,
- 21 supplementary materials, a combination of a book, workbook, and
- 22 supplementary materials, computer software, magnetic media, DVD,
- 23 CD-ROM, computer courseware, on-line services, or an electronic
- 24 medium, or other means of conveying information to the student or

- 1 otherwise contributing to the learning process through electronic
- 2 means, including open education resource [open-source]
- 3 instructional material.
- 4 (1-a) "Open education resource [Open-source]
- 5 instructional material" means teaching, learning, and research
- 6 resources that reside in the public domain or have been released
- 7 under an intellectual property license that allows for free use,
- 8 reuse, modification, and sharing with others, including full
- 9 courses, course materials, modules, textbooks, streaming videos,
- 10 tests, software, and any other tools, materials, or techniques used
- 11 to support access to knowledge [electronic instructional material
- 12 that is available for downloading from the Internet at no charge to
- 13 a student and without requiring the purchase of an unlock code,
- 14 membership, or other access or use charge, except for a charge to
- 15 order an optional printed copy of all or part of the instructional
- 16 material]. The term includes state-developed open education
- 17 <u>resource</u> [open-source] instructional material purchased under
- 18 Subchapter B-1.
- 19 SECTION 3. Section 31.004(b), Education Code, is amended to
- 20 read as follows:
- 21 (b) To determine whether each student has instructional
- 22 materials that cover all elements of the essential knowledge and
- 23 skills as required by Subsection (a), a school district or
- 24 open-enrollment charter school may consider:
- 25 (1) instructional materials adopted by the State Board
- 26 of Education;
- 27 (2) materials adopted or purchased by the commissioner

- 1 under Section 31.0231 or Subchapter B-1;
- 2 (3) <u>open education resource</u> [open-source]
- 3 instructional materials submitted by eligible institutions and
- 4 adopted by the State Board of Education under Section 31.0241;
- 5 (4) open education resource [open-source]
- 6 instructional materials made available by other public schools; and
- 7 (5) instructional materials developed or purchased by
- 8 the school district or open-enrollment charter school.
- 9 SECTION 4. Sections 31.005 and 31.021, Education Code, are
- 10 amended to read as follows:
- 11 Sec. 31.005. FUNDING FOR OPEN-ENROLLMENT CHARTER SCHOOLS.
- 12 An open-enrollment charter school is entitled to the instructional
- 13 materials and technology allotment under this chapter and is
- 14 subject to this chapter as if the school were a school district.
- 15 Sec. 31.021. STATE INSTRUCTIONAL MATERIALS AND TECHNOLOGY
- 16 FUND. (a) The state instructional materials and technology fund
- 17 consists of:
- 18 (1) an amount set aside by the State Board of Education
- 19 from the available school fund, in accordance with Section
- 20 43.001(d); and
- 21 (2) all amounts lawfully paid into the fund from any
- 22 other source.
- 23 (c) Money in the state instructional materials <u>and</u>
- 24 <u>technology</u> fund shall be used to:
- 25 (1) fund the instructional materials and technology
- 26 allotment, as provided by Section 31.0211;
- 27 (2) purchase special instructional materials for the

- 1 education of blind and visually impaired students in public
- 2 schools;
- 3 (3) pay the expenses associated with the instructional
- 4 materials adoption and review process under this chapter;
- 5 (4) pay the expenses associated with the purchase or
- 6 licensing of open education resource [open-source] instructional
- 7 material;
- 8 (5) pay the expenses associated with the purchase of
- 9 instructional material, including intrastate freight and shipping
- 10 and the insurance expenses associated with intrastate freight and
- 11 shipping; and
- 12 (6) [fund the technology lending grant program
- 13 established under Section 32.201; and
- 14 $\left[\frac{(7)}{7}\right]$ provide funding to the Texas School for the
- 15 Blind and Visually Impaired, the Texas School for the Deaf, and the
- 16 Texas Juvenile Justice Department.
- 17 (d) Money transferred to the state instructional materials
- 18 and technology fund remains in the fund until spent and does not
- 19 lapse to the state at the end of the fiscal year.
- SECTION 5. The heading to Section 31.0211, Education Code,
- 21 is amended to read as follows:
- Sec. 31.0211. INSTRUCTIONAL MATERIALS AND TECHNOLOGY
- 23 ALLOTMENT.
- SECTION 6. Sections 31.0211(a), (b), and (c), Education
- 25 Code, are amended to read as follows:
- 26 (a) A school district is entitled to an allotment each
- 27 biennium from the state instructional materials and technology fund

- 1 for each student enrolled in the district on a date during the last
- 2 year of the preceding biennium specified by the commissioner. The
- 3 commissioner shall determine the amount of the allotment per
- 4 student each biennium on the basis of the amount of money available
- 5 in the state instructional materials and technology fund to fund
- 6 the allotment. An allotment under this section shall be
- 7 transferred from the state instructional materials and technology
- 8 fund to the credit of the district's instructional materials and
- 9 technology account as provided by Section 31.0212.
- 10 (b) A juvenile justice alternative education program under
- 11 Section 37.011 is entitled to an allotment from the state
- 12 instructional materials and technology fund in an amount determined
- 13 by the commissioner. The program shall use the allotment to
- 14 purchase items listed in Subsection (c) for students enrolled in
- 15 the program. The commissioner's determination under this
- 16 subsection is final and may not be appealed.
- 17 (c) Subject to Subsection (d), funds allotted under this
- 18 section may be used to:
- 19 (1) purchase:
- 20 (A) materials on the list adopted by the
- 21 commissioner, as provided by Section 31.0231;
- 22 (B) instructional materials, regardless of
- 23 whether the instructional materials are on the list adopted under
- 24 Section 31.024;
- 25 (C) consumable instructional materials,
- 26 including workbooks;
- 27 (D) instructional materials for use in bilingual

- 1 education classes, as provided by Section 31.029;
- 2 (E) instructional materials for use in college
- 3 preparatory courses under Section 28.014, as provided by Section
- 4 31.031;
- 5 (F) supplemental instructional materials, as
- 6 provided by Section 31.035;
- 7 (G) state-developed open education resource
- 8 [open-source] instructional materials, as provided by Subchapter
- 9 B-1;
- 10 (H) instructional materials and technological
- 11 equipment under any continuing contracts of the district in effect
- 12 on September 1, 2011; and
- 13 (I) technological equipment necessary to support
- 14 the use of materials included on the list adopted by the
- 15 commissioner under Section 31.0231 or any instructional materials
- 16 purchased with an allotment under this section; and
- 17 (2) pay:
- 18 (A) for training educational personnel directly
- 19 involved in student learning in the appropriate use of
- 20 instructional materials and for providing for access to
- 21 technological equipment for instructional use; and
- 22 (B) the salary and other expenses of an employee
- 23 who provides technical support for the use of technological
- 24 equipment directly involved in student learning.

- 4 (h) The board shall include information regarding open
- 5 education resource instructional materials during the adoption
- 6 cycle, including any cost savings associated with the adoption of
- 7 open education resource instructional materials.
- 8 SECTION 14. Section 31.0231(b), Education Code, is amended

- 10 (b) A school district may select material on the list
- 11 adopted under Subsection (a) to be funded by the district's
- 12 instructional materials and technology allotment under Section

- 24 (1) the instructional material is written, compiled,
- 25 or edited primarily by faculty of the eligible institution who
- 26 specialize in the subject area of the instructional material;
- 27 (2) the eligible institution identifies each

- 1 contributing author;
- 2 (3) the appropriate department of the eligible
- 3 institution certifies the instructional material for accuracy; and
- 4 (4) the eligible institution determines that the
- 5 instructional material qualifies for placement on the list based on
- 6 the extent to which the instructional material covers the essential
- 7 knowledge and skills identified under Section 28.002 for the
- 8 subject for which the instructional material is written and
- 9 certifies that:
- 10 (A) for instructional material for a
- 11 senior-level course, a student who successfully completes a course
- 12 based on the instructional material will be prepared, without
- 13 remediation, for entry into the eligible institution's
- 14 freshman-level course in that subject; or
- 15 (B) for instructional material for a
- 16 junior-level and senior-level course, a student who successfully
- 17 completes the junior-level course based on the instructional
- 18 material will be prepared for entry into the senior-level course.
- 19 SECTION 17. Section 31.0242, Education Code, is amended to

- 18 SECTION 20. Section 31.027(c), Education Code, is amended

- 12 (c) The commissioner may provide a license to use
- 13 state-developed <u>open education resource</u> [open-source]
- 14 instructional material to an entity not listed in Subsection (b).
- 15 In determining the cost of a license under this subsection, the
- 16 commissioner shall seek, to the extent feasible, to recover the
- 17 costs of developing, revising, and distributing state-developed
- 18 open education resource [open-source] instructional materials.
- 19 SECTION 26. Section 31.076(b), Education Code, is amended
- 20 to read as follows:
- 21 (b) A decision by the commissioner regarding the purchase,
- 22 revision, cost, or distribution of state-developed open education
- 23 <u>resource</u> [open-source] instructional material is final and may not
- 24 be appealed.
- 25 SECTION 27. Section 31.077, Education Code, is amended to
- 26 read as follows:
- Sec. 31.077. ADOPTION SCHEDULE. The commissioner shall

- 1 develop a schedule for the adoption of state-developed open
- 2 education resource [open-source] instructional materials under
- 3 this subchapter. In developing the adoption schedule under this
- 4 section, the commissioner shall consider:
- 5 (1) the availability of funds;
- 6 (2) the existing instructional material adoption
- 7 cycles under Subchapter B; and
- 8 (3) the availability of instructional materials for
- 9 development or purchase by the state.
- SECTION 28. Section 31.101, Education Code, is amended by

- SECTION 35. Section 403.093(d), Government Code, is amended

The comptroller shall make the transfers in 2 installments as necessary to comply with Section 42.259, Education Code, and permit the Texas Education Agency, to the extent 4 5 authorized by the General Appropriations Act, to make temporary transfers from the foundation school fund for payment of the 6 instructional materials and technology allotment under Section 7 8 31.0211, Education Code. Unless an earlier date is necessary for purposes of temporary transfers for payment of the instructional 9 materials and technology allotment, an installment must be made not 10 earlier than two days before the date an installment to school 11 districts is required by Section 42.259, Education Code, and must 12 not exceed the amount necessary for that payment and any temporary 13 14 transfers for payment of the instructional materials and technology 15 allotment.

SECTION 36. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.
