A BILL TO BE ENTITLED

2	relating to the qualifications, duties, and limitations of Texas

5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle Z, Title 3, Government Code, is amended
7	by adding Chapter 393 to read as follows:
8	CHAPTER 393. DELEGATES TO FEDERAL ARTICLE V CONVENTIONS
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 393.001. DEFINITIONS. In this chapter:
11	(1) "Alternate delegate" means an individual
12	appointed under Section 393.051 to represent this state as an
13	alternate delegate at an Article V convention.
14	(2) "Article V convention" means a convention called
15	by the United States Congress under Article V of the United States
16	Constitution.
17	(3) "Delegate" means:
18	(A) an individual appointed under Section
19	393.051 to represent this state as a delegate at an Article V
20	<pre>convention; or</pre>
21	(B) an alternate delegate who fills a vacancy in
22	the office of the alternate delegate's paired delegate.
23	(4) "Unauthorized vote" means a vote cast by a
24	delegate or alternate delegate at an Article V convention that:

1 (A) is contrary to the instructions adopted under 2 Section 393.101 in effect at the time the vote is taken; (B) exceeds the scope or subject matter of the 3 Article V convention as authorized by the legislature in the 4 5 application to the United States Congress to call the convention if the legislature made an application to call the convention; or 6 7 (C) exceeds the scope or subject matter of the 8 Article V convention if the legislature did not make an application to the United States Congress to call the convention. 9 Sec. 393.002. RULES AND PROCEDURES. (a) The legislature by 10 concurrent resolution shall provide the rules and procedures 11 12 necessary to implement this chapter. (b) A legislative action relating to the appointment or 13 14 recall of a delegate or alternate delegate, the filling of a vacancy 15 in the office of a delegate or alternate delegate, or the determination of an unauthorized vote may be accomplished through a 16 17 resolution adopted by the house that takes the action. SUBCHAPTER B. DELEGATES AND ALTERNATE DELEGATES 18 Sec. 393.051. APPOINTMENT. (a) As soon as possible 19 following the calling of an Article V convention, the legislature 20 21 shall appoint delegates and alternate delegates to the convention

- 3 (d) Service as a delegate or alternate delegate by a member
- 4 of the legislature is an additional duty of the member's
- 5 legislative office.
- 6 (e) The appointing house shall pair each alternate delegate
- 7 with a delegate at the time each appointment is made.
- 8 Sec. 393.052. VACANCY. (a) An alternate delegate
- 9 automatically fills a vacancy in the office of the alternate
- 10 delegate's paired delegate unless the office of the alternate
- 11 delegate is simultaneously vacated.
- 12 (b) Except as provided by Subsection (a), the house that
- 13 appointed a delegate or alternate delegate shall fill a vacancy in
- 14 the office of the delegate or alternate delegate as soon as possible
- 15 <u>after the vacancy occurs.</u>
- Sec. 393.053. RECALL. (a) The house that appointed a
- 17 delegate or alternate delegate may recall the delegate or alternate
- 18 delegate.
- 19 (b) A vacancy created by the recall of a delegate or
- 20 alternate delegate shall be filled in the manner provided by
- 21 <u>Section 393.052.</u>
- Sec. 393.054. COMPENSATION; REIMBURSEMENT OF EXPENSES. (a)
- 23 A delegate or alternate delegate is not entitled to compensation
- 24 for service as a delegate or alternate delegate.
- 25 (b) A delegate or alternate delegate is entitled to
- 26 reimbursement for necessary expenses incurred in performance of
- 27 official duties, subject to any applicable limitation on

- 1 reimbursement provided by general law or the General Appropriations
- 2 Act.
- 3 Sec. 393.055. OATH. (a) An individual appointed as a
- 4 delegate or alternate delegate must take the following oath before
- 5 voting or taking an action as a delegate or alternate delegate of
- 6 this state: "I do solemnly swear (or affirm) that to the best of my
- 7 <u>abilities, I will, as a delegate (or alternate delegate) to the</u>
- 8 Article V Convention, act according to the limits of the authority
- 9 granted to me as a delegate or alternate delegate by Texas law, will
- 10 not consider or vote to approve an amendment to the United States
- 11 Constitution not authorized by the Texas Legislature in its
- 12 application to the United States Congress to call this convention
- 13 or an amendment outside the scope of this convention if the Texas
- 14 Legislature did not make an application to the United States
- 15 Congress to call this convention, and will faithfully abide by and
- 16 <u>execute the instructions to delegates or alternate delegates</u>
- 17 adopted by the Texas Legislature."
- 18 (b) Each delegate and alternate delegate must file the
- 19 executed oath with the secretary of state.
- 20 SUBCHAPTER C. DUTIES OF DELEGATES AND ALTERNATE DELEGATES
- Sec. 393.101. INSTRUCTIONS TO DELEGATES AND ALTERNATE
- 22 DELEGATES. (a) At the time delegates and alternate delegates are
- 23 appointed, the legislature by joint resolution shall adopt
- 24 instructions to the delegates and alternate delegates to govern the
- 25 actions of those officers at the Article V convention.
- 26 (b) The legislature may not adopt instructions for an
- 27 Article V convention called following an application by the

- 1 legislature to the United States Congress for the convention that
- 2 authorize a delegate or alternate delegate to consider or vote to
- 3 approve an amendment to the United States Constitution that is not
- 4 authorized by the legislature in its application for the
- 5 convention.
- 6 (c) The legislature by joint resolution may amend the
- 7 instructions at any time.
- 8 Sec. 393.102. DUTY OF ALTERNATE DELEGATE. An alternate
- 9 delegate shall act in the place of the alternate delegate's paired
- 10 delegate when the delegate is absent from the convention.
- Sec. 393.103. UNAUTHORIZED VOTE. (a) A delegate or
- 12 alternate delegate may not cast an unauthorized vote.
- 13 <u>(b)</u> The determination that a vote is an unauthorized vote
- 14 may only be made by the house that appointed the delegate or
- 15 <u>alternate delegate who cast the vote.</u>
- 16 <u>(c) A vote determined to be an unauthorized vote is invalid.</u>
- 17 (d) A delegate or alternate delegate who casts a vote
- 18 determined to be an unauthorized vote is disqualified to continue
- 19 to serve as a delegate or alternate delegate. A vacancy in the
- 20 office of a delegate or alternate delegate created by the
- 21 disqualification of the delegate or alternate delegate shall be
- 22 filled in the manner provided by Section 393.052.
- (e) The presiding officer of the house that determined that
- 24 a delegate or alternate delegate has cast an unauthorized vote
- 25 shall promptly notify the head of the state delegation and the
- 26 presiding officer of the Article V convention that the delegate or
- 27 alternate delegate has cast an unauthorized vote and is

1 <u>disqualified to serve as a delegate or alternate delegate.</u>

- 2 SECTION 2. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2017.
