- 6 SECTION 1. Subchapter A, Chapter 13, Election Code, is
- 7 amended by adding Section 13.009 to read as follows:
- 8 Sec. 13.009. VOTER REGISTRATION THROUGH DEPARTMENT OF
- 9 PUBLIC SAFETY. (a) The voter registrar of each county shall
- 10 automatically register any county resident who is eligible to vote
- 11 as provided by Section 13.001 and:
- 12 (1) is issued a Texas driver's license or a personal
- 13 identification card by the Department of Public Safety; or
- 14 (2) makes a change to a Texas driver's license or
- 15 personal identification card issued by the Department of Public
- 16 Safety.
- 17 (b) A driver's license or personal identification card
- 18 transaction with an indication provided by Section 20.062(b) or
- 19 <u>20.063(c)</u> that the transaction is not for voter registration
- 20 purposes is not subject to this section.

- 3 SECTION 3. Section 20.062(b), Election Code, is amended to
- 4 read as follows:
- 5 (b) The department shall prescribe and use a change of
- 6 address form and procedure that combines department and voter
- 7 registration functions. The form must allow a licensee or
- 8 cardholder to indicate that [whether] the change of address is not
- 9 [also to be used] for voter registration purposes.
- 10 SECTION 4. Section 20.063, Election Code, is amended to
- 11 read as follows:
- 12 Sec. 20.063. REGISTRATION PROCEDURES. (a) The Department
- 13 of Public Safety shall consider an application made in person, by
- 14 mail, or online at the department's Internet website [provide to
- 15 each person who applies in person at the department's offices] for
- 16 an original or renewal of a driver's license, a personal
- 17 identification card, or a duplicate or corrected license or card by
- 18 a person who is eligible to vote as provided by Section 13.001 an
- 19 application for [opportunity to complete a] voter registration.
- 20 The date of application is considered to be the date of submission
- 21 to the voter registrar for the purpose of determining the effective
- 22 date of registration [application form].
- 23 (b) The Department of Public Safety shall consider a change
- 24 of address that relates to [When the department processes] a
- 25 license or card <u>and that is submitted to</u> [for renewal by mail,] the
- 26 department [shall deliver to the applicant by mail a voter
- 27 registration application form.

[(c) A change of address that relates to a license or card and that is submitted to the department] in person, [or] by mail, or online at the department's Internet website [serves] as a change in [of address for] voter registration [unless the licensee or cardholder indicates that the change is not for voter registration purposes]. The date of submission of a change of address to a department employee is considered to be the date of submission to the voter registrar for the purpose of determining the effective date of registration [only].

- (c) The registration of an eligible [(d) If a completed] 10 voter as required by Subsections (a) and (b) is automatic unless the 11 person indicates that the transaction is not for voter 12 registration purposes [application submitted to a department 13 employee does not include the applicant's correct driver's license 14 15 number or personal identification card number, a department employee shall enter the appropriate information on the 16 17 application. If a completed application does not include the applicant's correct residence address or mailing address, a 18 department employee shall obtain the appropriate information from 19 the applicant and enter the information on the application]. 20
- 21 SECTION 5. Section 20.065(b), Election Code, is amended to 22 read as follows:
- (b) Each weekday the department is regularly open for business, the department shall electronically transfer to the secretary of state the name and information designated by the secretary of state for [of each person who completes a] voter registration for each individual who is eligible to vote as

- 2 <u>at the department's Internet website for an original or renewal of a</u>
- 3 driver's license, a personal identification card, or a duplicate or
- 4 corrected license or card [application submitted to the

- 6 implement this subsection.
- 7 SECTION 6. This Act takes effect September 1, 2017.
