4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 12.104, Education Code, is amended by
6	amending Subsection (b-2) and adding Subsection (b-3) to read as
7	follows:
8	(b-2) An open-enrollment charter school is subject to the
9	requirement to establish an individual graduation committee under
10	Section 28.0258. This subsection expires September 1, $\underline{2019}$ [ $\underline{2017}$ ].
11	(b-3) An open-enrollment charter school is subject to the
12	requirement to establish an individual graduation committee under
13	Section 28.02581. This subsection expires September 1, 2019.
14	SECTION 2. Section 28.025(c-6), Education Code, is amended
15	to read as follows:
16	(c-6) Notwithstanding Subsection (c), a person may receive
17	a diploma if the person is eligible for a diploma under Section
18	28.0258. This subsection expires September 1, $\underline{2019}$ [ $\underline{2017}$ ].
19	SECTION 3. Effective September 1, 2018, Section 28.0258(e),

- 10 INDIVIDUAL GRADUATION COMMITTEE REVIEW FOR CERTAIN STUDENTS WHO
- 11 ENTERED THE NINTH GRADE BEFORE 2011-2012. (a) This section
- 12 applies only to a student who:
- 13 (1) entered the ninth grade before the 2011-2012
- 14 school year;
- 15 (2) successfully completed the curriculum
- 16 requirements for high school graduation applicable to the student;
- 17 <u>and</u>
- 18 (3) failed to comply with any exit-level assessment
- 19 instrument performance requirements for assessment instruments
- 20 administered under Section 39.023(c), as that section existed
- 21 before amendment by Chapter 1312 (S.B. 1031), Acts of the 80th
- 22 Legislature, Regular Session, 2007.
- 23 (b) For each student to whom this section applies, the
- 24 school district in which the student is enrolled or was last
- 25 enrolled, on request by the student, shall establish an individual
- 26 graduation committee to determine whether the student may qualify
- 27 to graduate as provided by this section. The committee shall be

1	composed of:
2	(1) the principal or principal's designee;
3	(2) for each exit-level assessment instrument on which
4	the student failed to perform satisfactorily, a teacher in the
5	applicable subject area;
6	(3) the department chair or lead teacher supervising
7	the teacher described by Subdivision (2); and
8	(4) the student for whom the committee is established.
9	(c) The commissioner by rule shall establish a procedure for
10	appointing an alternative committee member if a person described by
11	Subsection (b)(1), (2), or (3) is unable to serve. The
12	superintendent of each school district shall establish procedures
13	for the convening of an individual graduation committee.
14	(d) The school district shall ensure a good faith effort is
15	made to timely notify the student for whom the individual
16	graduation committee is established of the time and place for
17	convening the committee. The notice must be:
18	(1) provided in person or by regular mail or e-mail;
19	and
20	(2) clear and easy to understand.
21	(e) Notwithstanding any other law, an individual graduation
22	committee established under this section shall recommend
23	additional requirements by which the student for whom the committee
24	is established may qualify to graduate, including:
25	(1) additional remediation; and
26	(2) for each exit-level assessment instrument on which
27	the student failed to perform satisfactorily:

1 (A) the completion of a project related to the 2 subject area that demonstrates proficiency in the subject area; or 3 (B) the preparation of a portfolio of work samples in the subject area, including work samples that 4 demonstrate proficiency in the subject area. 5 (f) For purposes of Subsection (e), the student may submit 6 7 to the individual graduation committee coursework previously completed to satisfy a recommended additional requirement. 8 9 (g) In determining whether a student for whom an individual graduation committee is established is qualified to graduate, the 10 11 committee shall consider: (1) any recommendation of the teacher of the student 12 13 in a subject area for which the student failed to perform 14 satisfactorily on an exit-level assessment instrument; 15 (2) the student's grade in each course of the subject 16 for which the student failed to perform satisfactorily on an 17 exit-level assessment instrument; 18 (3) the student's score on each exit-level assessment instrument on which the student failed to perform satisfactorily; 19 (4) the student's performance on any additional 20 requirements recommended by the committee under Subsection (e); 21 22 (5) the number of hours of remediation that the 23 student has attended, including attendance in and successful completion of a transitional college course in reading or 24 25 mathematics; (6) the student's school attendance rate during the 26

student's enrollment in high school;

1 (7) the student's satisfaction of any of the Texas 2 Success Initiative (TSI) college readiness benchmarks prescribed 3 by the Texas Higher Education Coordinating Board; (8) the student's successful completion of a dual 4 credit course in English, mathematics, science, or social studies; 5 6 (9) the student's successful completion of a high 7 school pre-advanced placement, advanced placement, or international baccalaureate program course 8 9 mathematics, science, or social studies; 10 (10) the student's rating of advanced high on the high 11 school administration of the Texas English Language Proficiency 12 Assessment System; 13 (11) the student's score of 50 or greater on a 14 College-Level Examination Program examination; (12) the student's score on the ACT, the SAT, or the 15 16 Armed Services Vocational Aptitude Battery test; 17 (13) the student's completion of a sequence of high school courses under a career and technical education program 18 required to attain an industry-recognized credential 19 20 certificate; (14) the student's overall preparedness 21 for postsecondary success; and 22 (15) any other academic information designated for 23 consideration by the board of trustees of the school district. 24 25 (h) After considering the criteria under Subsection (g), the individual graduation committee may determine that the student 26

is qualified to graduate. Notwithstanding any other law, a student

- 1 for whom an individual graduation committee is established may
- 2 graduate and receive a high school diploma on the basis of the
- 3 committee's decision only if the student successfully completes all
- 4 additional requirements recommended by the committee under
- 5 Subsection (e) and the committee's vote is unanimous. The
- 6 commissioner by rule shall establish a timeline for making a
- 7 determination under this subsection. This subsection does not
- 8 create a property interest in graduation. The decision of a
- 9 <u>committee</u> is final and may not be appealed.
- (i) The commissioner shall adopt rules as necessary to
- 11 <u>implement this section</u>.
- 12 (j) This section expires September 1, 2019.

- Sec. 28.02591. TEXAS HIGHER EDUCATION COORDINATING BOARD
- 24 REPORTING REQUIREMENTS FOR STUDENTS GRADUATING BASED ON INDIVIDUAL
- 25 GRADUATION COMMITTEE REVIEW PROCESS. (a) The Texas Higher
- 26 Education Coordinating Board, in coordination with the agency,
- 27 shall collect longitudinal data relating to the post-graduation

- 1 pursuits of each student who is awarded a diploma based on the
- 2 determination of an individual graduation committee under Section
- 3 28.0258, including whether the student:
- 4 (1) enters the workforce;
- 5 (2) enrolls in an associate degree or certificate
- 6 program at a public or private institution of higher education;
- 7 (3) enrolls in a bachelor's degree program at a public
- 8 or private institution of higher education; or
- 9 (4) enlists in the armed forces of the United States or
- 10 the Texas National Guard.
- 11 (b) Not later than December 1 of each even-numbered year,
- 12 the Texas Higher Education Coordinating Board shall provide a
- 13 report to the legislature that includes a summary compilation of
- 14 the data collected under Subsection (a) that is presented in a
- 15 manner that does not identify an individual student.
- 16 (c) The Texas Higher Education Coordinating Board and the
- 17 agency shall adopt rules as necessary to implement this section.
- SECTION 9. Section 39.025(a-2), Education Code, as added by
- 19 Chapter 5 (S.B. 149), Acts of the 84th Legislature, Regular
- 20 Session, 2015, is amended to read as follows:
- 21 (a-2) Notwithstanding Subsection (a), a student who has
- 22 failed to perform satisfactorily on end-of-course assessment
- 23 instruments in the manner provided under this section may receive a
- 24 high school diploma if the student has qualified for graduation
- 25 under Section 28.0258. This subsection expires September 1, 2019
- [2017].
- 27 SECTION 10. Section 39.025(a-3), Education Code, is amended

- 1 to read as follows:
- 2 (a-3) A student who, after retaking an end-of-course
- 3 assessment instrument for Algebra I or English II, has failed to
- 4 perform satisfactorily as required by Subsection (a), but who
- 5 receives a score of proficient on the Texas Success Initiative
- 6 (TSI) diagnostic assessment for the corresponding subject for which
- 7 the student failed to perform satisfactorily on the end-of-course
- 8 assessment instrument satisfies the requirement concerning the
- 9 Algebra I or English II end-of-course assessment, as applicable.
- 10 This subsection expires September 1, 2019 [2017].
- SECTION 11. Effective September 1, 2019, Section 39.025,
- 12 Education Code, is amended by amending Subsection (c-1) and adding
- 13 Subsection (c-2) to read as follows:
- 14 (c-1) A school district may not administer an assessment
- 15 instrument required for graduation administered under this section
- 16 as this section existed:
- 17 (1) before September 1, 1999; or
- 18 (2) before amendment by Chapter 1312 (S.B. 1031), Acts
- 19 of the 80th Legislature, Regular Session, 2007.
- 20 (c-2) A school district may administer to a student who
- 21 failed to perform satisfactorily on an assessment instrument
- 22 described by <u>Subsection (c-1)</u> [this subsection] an alternate
- 23 assessment instrument designated by the commissioner. The
- 24 commissioner shall determine the level of performance considered to
- 25 be satisfactory on an alternate assessment instrument. The
- 26 district may not administer to the student an assessment instrument
- 27 or a part of an assessment instrument that assesses a subject that

was not assessed in an assessment instrument applicable to the 1 student described by Subsection (c-1) [required for graduation 2 administered under this section as this section existed before 3 September 1, 1999]. The commissioner shall make available to districts information necessary to administer the alternate 5 assessment instrument authorized by this subsection. 6 7 commissioner's determination regarding designation of an appropriate alternate assessment instrument under this subsection 8 9 and the performance required on the assessment instrument is final and may not be appealed. 10

SECTION 12. Except as otherwise provided by this Act, this
Act takes effect immediately if it receives a vote of two-thirds of
all the members elected to each house, as provided by Section 39,
Article III, Texas Constitution. If this Act does not receive the
vote necessary for immediate effect, this Act takes effect
September 1, 2017.
