## A BILL TO BE ENTITLED AN ACT

1-19 relating to the election of the board of directors of the Panola County Groundwater Conservation District. 1-20 1-21

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1**-**22 SECTION 1. Section 8819.053, Special District Local Laws Code, is amended to read as follows: 1-23

1-24 Sec. 8819.053. ELECTION DATE. The district shall hold an election to elect the appropriate number of directors on the 1-25 1-26 1-27 uniform election date prescribed by Section 41.001, Election Code, in <u>November</u> [May] of each even-numbered year.

1-28 SECTION 2. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished 1-29 1-30 1-31 1-32 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 1-33 1-34 Government Code.

The governor, one of the required recipients, has the notice and Act to the Texas Commission on 1-35 (b) 1-36 submitted 1-37 Environmental Quality.

1-38 (c) The Texas Commission on Environmental Quality has filed 1-39 its recommendations relating to this Act with the governor, the 1-40 lieutenant governor, and the speaker of the house of 1-41 representatives within the required time.
