- 16 (12-b) "Legacy liability" means the unfunded
- 17 actuarial accrued liability:
- 18 (A) for the fiscal year ending June 30, 2016,
- 19 reduced to reflect:
- 20 (i) changes to benefits or contributions
- 21 under this article; and
- 22 (ii) payments by the municipality and
- 23 earnings at the assumed rate of return allocated to the legal

(12-e) "Liability layer" means the unanticipated 11 12 change as established in each risk sharing valuation study prepared under Section 13B or 13C of this article, as applicable. 13 (12-f) "Liability loss layer" means a liability layer 14 15 that increases the unfunded actuarial accrued liability. For purposes of this article, the legacy liability is a liability loss 16 17 layer. (12-g) "Maximum contribution rate" means the rate 18 19 equal to the corridor midpoint plus the corridor margin. 20 "Minimum contribution rate" means the rate (13-a) equal to the corridor midpoint minus the corridor margin ["Normal 21 retirement age" means the earlier of: 22 23 [(A) the age at which the member attains 20 years

- 12 percent of the pensionable payroll for the current fiscal year
- unless agreed to by the municipality. 13
- (13-e) "Normal retirement age" means: 14
- 15 (A) for a member, including a member who was
- hired before the year 2017 effective date and who involuntarily 16
- 17 separated from service but has been retroactively reinstated in
- accordance with an arbitration, civil service, or court ruling, 18
- 19 hired before the year 2017 effective date, the earlier of:
- 20 (i) the age at which the member attains 20
- 21 years of service; or
- (ii) the age at which the member first 22
- attains the age of at least 50 years and at least 10 years of 23
- 24 service; or
- (B) except as provided by Paragraph (A) of this 25

- 7 5A of this article. 8 (15-b) "Pension obligation bond" means a bond issued in accordance with Chapter 107, Local Government Code ["PROP 9 10 account" means the notional account established to reflect the credits and contributions of a member or surviving spouse who has 11 12 made a PROP election in accordance with Section 5A of this article]. (15-c) "Pensionable payroll" means the aggregate 13 salary of all the firefighters on active service in an applicable 14 15 fiscal year.
- 16 (15-d) "Price inflation assumption" means:
- 17 (A) the most recent headline consumer price index
- 18 <u>10-year forecast published in the Federal Reserve Bank of</u>
- 19 Philadelphia Survey of Professional Forecasters; or
- 20 (B) if the forecast described by Paragraph (A) of
- 21 this subdivision is not available, another standard as determined
- 22 by mutual agreement between the municipality and the board.
- 23 (15-e) "Projected pensionable payroll" means the

- 13 Section 5A of this article before the year 2017 effective date.
- 14 (16) "Salary" means wages as defined by Section
- 15 3401(a) of the code, [the amounts includable in gross income of a
- 16 member] plus any amount not includable in gross income under
- 17 Section 104(a)(1), Section 132(f) $[\frac{125}{2}]$, Section 402(g)(2)
- 18 [402(e)(3) or (h)], Section 457 [403(b)], or Section 414(h)(2)
- 19 [414(h)] of the code, except that with respect to salary earned on
- 20 or after the year 2017 effective date, gross income excludes
- 21 overtime pay received by a member or the amount by which the salary
- 22 earned by a member on the basis of the member's appointed position
- 23 exceeds the salary of the member's highest tested rank.
- 24 (16-a) "Third quarter line rate" means the corridor
- 25 midpoint plus 2.5 percentage points.
- 26 (16-b) "Unfunded actuarial accrued liability" means
- 27 the difference between the actuarial accrued liability and the

- 1 <u>actuarial value of assets. For purposes of this definition:</u>
- 2 (A) "actuarial accrued liability" means the
- 3 portion of the actuarial present value of projected benefits
- 4 attributed to past periods of member service based on the cost
- 5 method used in the risk sharing valuation study prepared under
- 6 Section 13B or 13C of this article, as applicable; and
- 7 (B) "actuarial value of assets" means the value
- 8 of fund investments as calculated using the asset smoothing method
- 9 used in the risk sharing valuation study prepared under Section 13B
- 10 or 13C of this article, as applicable.
- 11 (16-c) "Unanticipated change" means, with respect to
- 12 the unfunded actuarial accrued liability in each risk sharing
- 13 valuation study prepared under Section 13B or 13C of this article,
- 14 as applicable, the difference between:
- 15 (A) the remaining balance of all then-existing
- 16 liability layers as of the date of the risk sharing valuation study;

- 23 or employee of the board or fund, from any obligation to implement a

- 3 Sec. 1B. FISCAL YEAR. The fund or the municipality or both
- 4 may only change their respective fiscal years by entering into a
- 5 written agreement. If the fund and municipality enter into an
- 6 agreement described by this section, the parties shall, in the
- 7 agreement, adjust the provisions of Sections 13A through 13F of
- 8 this article to reflect that change.
- 9 Sec. 1C. ALTERNATIVE PLANS. The fund and the municipality
- 10 may enter into a written agreement to offer an alternative plan or
- 11 plans, including defined contribution plans, if both parties
- 12 consider it appropriate.
- SECTION 1.03. Section 2, Article 6243e.2(1), Revised
- 14 Statutes, is amended by amending Subsection (b) and adding
- 15 Subsection (t) to read as follows:
- 16 (b) The board of trustees of the fund shall be known as the
- 17 "(name of municipality) Firefighters' Relief and Retirement Fund
- 18 Board of Trustees" and the fund shall be known as the "(name of
- 19 municipality) Firefighters' Relief and Retirement Fund." The board
- 20 consists of 10 trustees, including:
- 21 (1) the mayor or an appointed representative of the
- 22 mayor;
- 23 (2) the <u>director of finance or the director of</u>
- 24 finance's designee [treasurer] of the municipality or, if there is
- 25 not a <u>director of finance</u> [treasurer], the <u>highest ranking employee</u>
- 26 of the municipality, excluding elected officials, with
- 27 predominately financial responsibilities, as determined by the

- 1 mayor, or that employee's designee [secretary, clerk, or other
- 2 person who by law, charter provision, or ordinance performs the
- 3 duty of treasurer of the municipality];
- 4 (3) five firefighters who are members of the fund;
- 5 (4) one person who is a retired firefighter and a
- 6 member of the fund with at least 20 years of participation; and
- 7 (5) two persons, each of whom is a registered voter of
- 8 the municipality, has been a resident of the municipality for at
- 9 least one year preceding the date of initial appointment, and is not
- 10 a municipal officer or employee.
- 11 (t) The officers and employees of the municipality are fully
- 12 protected and free of liability for any action taken or omission
- 13 made or any action or omission suffered by them in good faith,
- 14 objectively determined, in the performance of their duties related
- 15 to the fund. The protection from liability provided by this
- 16 subsection is cumulative of and in addition to any other
- 17 constitutional, statutory, or common law official or governmental
- 18 immunity, defense, and civil or procedural protection provided to
- 19 the municipality as a governmental entity and to a municipal
- 20 official or employee as an official or employee of a governmental
- 21 entity. Except for a waiver expressly provided by this article,
- 22 this article does not grant an implied waiver of any immunity.
- SECTION 1.04. Article 6243e.2(1), Revised Statutes, is
- 24 amended by adding Sections 2A, 2B, and 2C to read as follows:
- Sec. 2A. QUALIFICATIONS OF FUND ACTUARY. An actuary hired
- 26 under Section 3(b)(3) of this article must have at least five years
- 27 of experience as an actuary working with one or more public

- 1 retirement systems and must be a fellow of the Society of Actuaries,
- 2 a member of the American Academy of Actuaries, or an enrolled
- 3 actuary under the Employees Retirement Income Security Act of 1974
- 4 (29 U.S.C. <u>Section 1001 et seq.</u>).
- 5 Sec. 2B. QUALIFICATIONS OF MUNICIPAL ACTUARY. (a) Ar
- 6 actuary hired by the municipality for purposes of this article must
- 7 be an actuary from a professional service firm who:
- 8 (1) is not already engaged by the fund or any other
- 9 pension system authorized under Article 6243g-4, Revised Statutes,
- 10 or Chapter 88 (H.B. 1573), Acts of the 77th Legislature, Regular
- 11 Session, 2001 (Article 6243h, Vernon's Texas Civil Statutes), to
- 12 provide actuarial services to the fund or pension system, as
- 13 applicable;
- 14 (2) has a minimum of five years of professional
- 15 <u>actuarial experience; and</u>
- 16 (3) is a fellow of the Society of Actuaries or a member
- 17 of the American Academy of Actuaries and who, in carrying out duties
- 18 for the municipality, has met the applicable requirements to issue
- 19 statements of actuarial opinion.
- 20 (b) Notwithstanding Subsection (a) of this section, the
- 21 municipal actuary does not need to meet any greater qualifications
- 22 than those required by the board for the fund actuary.
- Sec. 2C. REPORT ON INVESTMENTS BY INDEPENDENT INVESTMENT
- 24 CONSULTANT. At least once every three years, the board shall hire
- 25 an independent investment consultant to conduct a review of fund
- 26 investments and submit a report to the board and the municipality
- 27 concerning the review or demonstrate in the fund's annual financial

- 1 report that the review was conducted. The independent investment
- 2 consultant shall review and report on at least the following:
- 3 (1) the fund's compliance with its investment policy
- 4 statement, ethics policies, including policies concerning the
- 5 acceptance of gifts, and policies concerning insider trading;
- 6 (2) the fund's asset allocation, including a review
- 7 and discussion of the various risks, objectives, and expected
- 8 future cash flows;
- 9 (3) the fund's portfolio structure, including the
- 10 system's need for liquidity, cash income, liquid returns, and
- 11 inflation protection and the active, passive, or index approaches
- 12 used for different portions of the portfolio;
- 13 (4) investment manager or advisor performance reviews
- 14 and an evaluation of the processes used to select and evaluate
- 15 managers;
- 16 (5) benchmarks used for each asset class and
- 17 individual manager;
- 18 (6) an evaluation of fees and trading costs;
- 19 (7) an evaluation of investments in any leverage,
- 20 foreign exchange, or other hedging transaction; and
- 21 (8) an evaluation of investment-related disclosures
- 22 in the fund's <u>annual reports or valuations</u>.
- 23 SECTION 1.05. Sections 3(b) and (d), Article 6243e.2(1),
- 24 Revised Statutes, are amended to read as follows:
- 25 (b) The board may employ persons to perform any investment,
- 26 administrative, legal, medical, accounting, clerical, or other
- 27 service the board considers appropriate, including:

- 1 (1) a certified public accountant or firm of certified
- 2 public accountants to perform an audit of the fund at times and
- 3 intervals the board considers necessary;
- 4 (2) a professional investment manager or firm of
- 5 managers as provided by Section 802.204, Government Code;
- 6 (3) <u>subject to Section 2A of this article</u>, an actuary
- 7 or actuarial firm at times and for purposes the board considers
- 8 necessary or appropriate;
- 9 (4) an attorney or firm of attorneys to advise,
- 10 assist, or represent the board in any legal matter relating to the
- 11 fund, including litigation involving matters under this article; or
- 12 (5) a physician to examine a firefighter before the
- 13 firefighter becomes a member of the fund or to examine a member or
- 14 beneficiary applying for or receiving a disability pension or
- 15 survivor benefit.
- 16 (d) The board may have an actuarial valuation performed each
- 17 year, and for determining the municipality's contribution rate as
- 18 provided by Section 13(d) of this article, the board may adopt a new
- 19 actuarial valuation each year[, except that an actuarial valuation
- 20 that will result in an increased municipal contribution rate that
- 21 is above the statutory minimum may be adopted only once every three
- 22 years, unless the governing body of the municipality consents to a
- 23 more frequent increase].
- SECTION 1.06. Article 6243e.2(1), Revised Statutes, is
- 25 amended by adding Section 3A to read as follows:
- Sec. 3A. CERTAIN ALTERATIONS BY LOCAL AGREEMENT. (a)
- 27 Except as provided by Subsection (b) of this section, the board is

- 1 authorized, on behalf of the members or beneficiaries of the fund,
- 2 to alter benefit types or amounts, the means of determining
- 3 contribution rates, or the contribution rates provided under this
- 4 article if the alteration is included in a written agreement
- 5 between the board and the municipality. An agreement entered into
- 6 under this section:
- 7 <u>(1) must:</u>
- 8 (A) if the agreement concerns benefit increases,
- 9 other than benefit increases that are the result of Section 13E of
- 10 this article, adhere to the processes and standards set forth in
- 11 Section 10 of this article; and
- 12 (B) operate prospectively only; and
- (2) may not, except as provided by Sections 13A
- 14 through 13F of this article, have the effect or result of increasing
- 15 the unfunded liability of the fund.
- 16 (b) In a written agreement entered into between the
- 17 municipality and the board under this section, the parties may not:
- 18 (1) fundamentally alter Sections 13A through 13F of
- 19 this article;
- 20 (2) increase the assumed rate of return to more than
- 21 <u>seven percent per year;</u>
- 22 (3) extend the amortization period of a liability
- 23 layer to more than 30 years from the first day of the fiscal year
- 24 beginning 12 months after the date of the risk sharing valuation
- 25 study in which the liability layer is first recognized; or
- 26 (4) allow a municipal contribution rate in any year
- 27 that is less than or greater than the municipal contribution rate

- 1 required under Section 13E or 13F of this article, as applicable.
- 2 (c) If the board is directed or authorized in Sections 13A
- 3 through 13F of this article to effect an increase or decrease to
- 4 benefits or contributions, this article delegates the authority to
- 5 alter provisions concerning benefits and contributions otherwise
- 6 stated in this article in accordance with the direction or
- 7 authorization only to the extent the alteration is set forth in an
- 8 order or other written instrument and is consistent with this
- 9 section, the code, and other applicable federal law and
- 10 regulations. The order or other written instrument must be
- 11 included in each applicable risk sharing valuation study under
- 12 Section 8B or 8C of this article, as applicable, adopted by the
- 13 board, and published in a manner that makes the order or other
- 14 written instrument accessible to the members.
- SECTION 1.07. Section 4, Article 6243e.2(1), Revised
- 16 Statutes, is amended by amending Subsections (a) and (b) and adding
- 17 Subsections (b-1) and (b-2) to read as follows:
- 18 (a) A member [with at least 20 years of participation] who
- 19 terminates active service for any reason other than death is
- 20 entitled to receive a service pension provided by this section if
- 21 the member was:
- 22 (1) hired as a firefighter before the year 2017
- 23 effective date, including a member who was hired before the year
- 24 2017 effective date and who involuntarily separated from service
- 25 but has been retroactively reinstated in accordance with an
- 26 <u>arbitration, civil service, or court ruling, at the earlier of:</u>
- 27 (A) the age at which the member attains 20 years

- 14 performing a board function, may issue process or subpoena a
- 15 witness or the production of a book, record, or other document <u>as to</u>
- 16 any matter affecting retirement, disability, or death benefits
- 17 under any pension plan provided by the pension system. The
- 18 presiding officer of the board may issue, in the name of the board,
- 19 a subpoena only if a majority of the board approves. The presiding
- 20 officer of the board, or the presiding officer's designee, shall
- 21 administer an oath to each witness. A peace officer shall serve a
- 22 subpoena issued by the board. If the person to whom a subpoena is
- 23 directed fails to comply, the board may bring suit to enforce the
- 24 subpoena in a district court of the county in which the person
- 25 resides or in the county in which the book, record, or other
- 26 document is located. If the district court finds that good cause
- 27 exists for issuance of the subpoena, the court shall order

- 1 compliance. The district court may modify the requirements of a
- 2 subpoena that the court finds are unreasonable. Failure to obey the
- 3 order of the district court is punishable as contempt.
- 4 (i) If the board or its designee determines that any person
- 5 to whom a payment under this article is due is a minor or is unable
- 6 to care for the person's affairs because of a physical or mental
- 7 disability, and if the board or its designee, as applicable,
- 8 determines the person does not have a guardian or other legal
- 9 representative and that the estate of the person is insufficient to
- 10 justify the expense of establishing a guardianship, or continuing a
- 11 guardianship after letters of guardianship have expired, then until
- 12 current letters of guardianship are filed with the pension system,
- 13 the board or its designee, as applicable, may make the payment:
- 14 (1) to the spouse of the person, as trustee for the
- 15 person;
- 16 (2) to an individual or entity actually providing for
- 17 the needs of and caring for the person, as trustee for the person;
- 18 or
- 19 (3) to a public agency or private charitable
- 20 organization providing assistance or services to the aged or
- 21 incapacitated that agrees to accept and manage the payment for the
- 22 benefit of the person as a trustee.
- 23 <u>(j) The board or its designee is not responsible for</u>
- 24 overseeing how a person to whom payment is made under Subsection (i)
- 25 of this section uses or otherwise applies the payments. Payments
- 26 made under Subsection (i) of this section constitute a complete
- 27 discharge of the pension system's liability and obligation to the

- 1 person on behalf of whom payment is made.
- 2 SECTION 2.10. Section 8(a), Article 6243g-4, Revised
- 3 Statutes, is amended to read as follows:
- 4 (a) Subject to adjustments authorized by Section 9D or 9E of
- 5 this article, each [Each] active member of the pension system shall
- 6 pay into the system each month 10.5 [8-3/4] percent of the member's
- 7 [total direct] pay. The payments shall be deducted by the city from
- 8 the salary of each active member each payroll period and paid to the
- 9 pension system. Except for the repayment of withdrawn
- 10 contributions under Section 17(f) [or 18(c)(3)] of this article and
- 11 rollovers permitted by Section 17(h) of this article, a person may
- 12 not be required or permitted to make any payments into the pension
- 13 system after the person separates from service.
- SECTION 2.11. Section 9, Article 6243g-4, Revised Statutes,
- 15 is amended to read as follows:
- Sec. 9. CONTRIBUTIONS BY THE CITY. (a) Beginning with the
- 17 year 2017 effective date, the city shall make contributions to the
- 18 pension system for deposit into the fund as provided by this section
- 19 and Section 9B, 9D, or 9E of this article, as applicable. The city
- 20 shall contribute:
- 21 (1) except by written agreement between the city and
- 22 the pension board under Section 27 of this article providing for an
- 23 <u>earlier contribution date</u>, beginning with the year 2017 effective

- 2 (2) for each fiscal year after the fiscal year ending
- 3 June 30, 2018, an amount, as determined in accordance with the
- 4 subsequent risk sharing valuation study conducted under Section 9A
- 5 of this article, equal to the city contribution rate multiplied by
- 6 the pensionable payroll for the applicable fiscal year.
- 7 (b) At least biweekly, the city shall make the contributions
- 8 required by Subsection (a) of this section by depositing with the
- 9 pension system an amount equal to the city contribution rate
- 10 multiplied by the pensionable payroll for the biweekly period.
- (c) Subject to Section 9D or 9E of this article, the city
- 12 contribution rate:
- 13 (1) except as provided by Subdivision (2) of this
- 14 subsection, is a percent that equals the sum of the employer normal
- 15 cost rate and the amortization rate for all liability layers; and
- 16 (2) may not exceed the maximum contribution rate or be
- 17 less than the minimum contribution rate [The city shall make
- 18 substantially equal contributions to the fund as soon as
- 19 administratively feasible after each payroll period. For each
- 20 fiscal year ending after June 30, 2005, the city's minimum
- 21 contribution shall be the greater of 16 percent of the members'
- 22 total direct pay or the level percentage of salary payment required
- 23 to amortize the unfunded actuarial liability over a constant period
- 24 of 30 years computed on the basis of an acceptable actuarial reserve
- 25 funding method approved by the board. However, for the fiscal year
- 26 ending June 30, 2002, the city's contribution shall be \$32,645,000,
- 27 for the fiscal year ending June 30, 2003, the city's contribution

- 1 shall be \$34,645,000, for the fiscal year ending June 30, 2004, the
- 2 city's contribution shall be \$36,645,000, and for the fiscal year
- 3 ending June 30, 2005, the city's contribution shall be 16 percent of
- 4 the members' total direct pay].
- 5 (d) In addition to the amounts required under this section,
- 6 the city may at any time contribute additional amounts to the
- 7 pension system for deposit in the pension fund by entering into a
- 8 written agreement with the pension board in accordance with Section
- 9 27 of this article.
- 10 (e) [(c)] The governing body of a city to which this article
- 11 applies by ordinance or resolution may provide that the city pick up
- 12 active member contributions required by Section 8 of this article
- 13 so that the contributions of all active members of the pension
- 14 system qualify as picked-up contributions under Section 414(h)(2)
- 15 of the code. If the governing body of a city adopts an ordinance or
- 16 resolution under this section, the city, the board, and any other
- 17 necessary party shall implement the action as soon as practicable.
- 18 Contributions picked up as provided by this subsection shall be
- 19 included in the determination of an active member's [total direct]
- 20 pay, deposited to the individual account of the active member on
- 21 whose behalf they are made, and treated for all purposes, other than

- 26 pension system shall only be credited against any amortization

- 2 to an amortization schedule of a liability layer under Section
- 9A(a)(4)(F), 9B(i), or 9D(c)(3)-(4) of this article.
- 4 (h) Notwithstanding any other law and except for the pension
- 5 obligation bond assumed under Section 9B(d)(2) of this article, the
- 6 city may not issue a pension obligation bond to fund the city
- 7 <u>contribution rate under this section.</u>
- 8 SECTION 2.12. Article 6243g-4, Revised Statutes, is amended
- 9 by adding Sections 9A, 9B, 9C, 9D, 9E, 9F, and 9G to read as follows:
- Sec. 9A. RISK SHARING VALUATION STUDIES. (a) The pension
- 11 system and the city shall prepare a risk sharing valuation study in
- 12 accordance with this section. A risk sharing valuation study must:
- 13 (1) be included in the pension system's standard

5	(i) except as provided by Subparagraph (ii)
6	of this paragraph and Section 9D(c)(1) or 9E(c)(1) of this article,
7	an asset smoothing method of reflecting actuarial losses and gains
8	experienced over a five-year period established in an actuarial
9	experience study applied prospectively beginning on the year 2017
10	effective date; and
11	(ii) for the initial risk sharing valuation
12	study prepared under Section 9B of this article, a marked-to-market
13	method applied as of June 30, 2016;
14	(C) closed layered amortization of liability
15	layers to ensure that the amortization period for each layer begins
16	12 months after the date of the risk sharing valuation study in
17	which the liability layer is first recognized;
18	(D) each liability layer is assigned an
19	amortization period;
20	(E) each liability loss layer amortized over a
21	period of 30 years from the first day of the fiscal year beginning
22	12 months after the date of the risk sharing valuation study in
23	which the liability loss layer is first recognized, except that the
24	legacy liability must be amortized from July 1, 2016, for a 30-year
25	period beginning July 1, 2017;
26	(F) the amortization period for each liability

gain layer being:

1	(i) equal to the remaining amortization
2	period on the largest remaining liability loss layer and the two
3	layers must be treated as one layer such that if the payoff year of
4	the liability loss layer is accelerated or extended, the payoff
5	year of the liability gain layer is also accelerated or extended; or

7	period of 30 years from the first day of the fiscal year beginning
8	12 months after the date of the risk sharing valuation study in

10	(G) liability layers, including the legacy

12	(H) the assumed rate of return, subject to
13	adjustment under Section 9D(c)(2) of this article or, if Section
14	9B(g) of this article applies, adjustment in accordance with a
15	written agreement entered into under Section 27 of this article;
16	(I) the price inflation assumption, which shall
17	be adjusted by plus or minus 50 basis points based on the most
18	recent actuarial experience study;
19	(J) projected salary increases and payroll
20	growth rate set in consultation with the city's finance director;
21	<u>and</u>
22	(K) payroll for purposes of determining the
23	corridor midpoint and city contribution rate must be projected
24	using the annual payroll growth rate assumption, which for purposes
25	of preparing any amortization schedule may not exceed three
26	percent; and
27	(5) be revised and restated, if appropriate, not later

- 1 than the 30th day after the date of a written agreement between the
- 2 city and the board entered into under Section 27 of this article.
- 3 (b) As soon as practicable after the end of a fiscal year,
- 4 the pension system actuary at the direction of the pension system
- 5 and the city actuary at the direction of the city shall separately
- 6 prepare a proposed risk sharing valuation study based on the fiscal
- 7 year that just ended.
- 8 <u>(c) Not later than September 30 following the end of the</u>
- 9 fiscal year, the pension system shall provide to the city actuary,
- 10 under a confidentiality agreement in which the city actuary agrees
- 11 to comply with the confidentiality provisions of Section 29 of this
- 12 article, the actuarial data described by Subsection (a)(2) of this
- 13 section.
- 14 (d) Not later than the 150th day after the last day of the
- 15 fiscal year:
- 16 (1) the pension system actuary, at the direction of
- 17 the pension system, shall provide the proposed risk sharing
- 18 valuation study prepared by the pension system actuary under
- 19 Subsection (b) of this section to the city actuary; and
- 20 (2) the city actuary, at the direction of the city,
- 21 shall provide the proposed risk sharing valuation study prepared by
- 22 the city actuary under Subsection (b) of this section to the pension
- 23 <u>system actuary.</u>
- (e) Each actuary described by Subsection (d) of this section
- 25 may provide copies of the proposed risk sharing valuation studies
- 26 to the city or to the pension system, as appropriate.
- 27 (f) If, after exchanging proposed risk sharing valuation

- 1 studies under Subsection (d) of this section, it is found that the
- 2 difference between the projected city contribution rate in the
- 3 proposed risk sharing valuation study prepared by the pension
- 4 system actuary and the projected city contribution rate in the risk
- 5 sharing valuation study prepared by the city actuary for the
- 6 corresponding fiscal year is:
- 7 (1) less than or equal to two percentage points, the
- 8 city contribution rate proposed by the pension system actuary will
- 9 be used, and the risk sharing valuation study prepared by the
- 10 pension system is considered to be the final risk sharing valuation

 8 system each shall deliver to the finance director of the city and

 9 the executive director of the pension system a final risk sharing

 10 valuation study with any agreed-to changes, marked as the final

 11 risk sharing valuation study for each actuary; and

 12 (ii) not later than the 90th day before the
- (ii) not later than the 90th day before the
 first day of the next fiscal year, the finance director and the
 executive director shall execute a joint addendum to the final risk
 sharing valuation study received by them under Subparagraph (i) of
 this paragraph that is a part of the final risk sharing valuation
 study for the fiscal year for all purposes and reflects the
 arithmetic average of the city contribution rates for the fiscal
 year stated in the final risk sharing valuation study.
- 20 (g) The assumptions and methods used and the types of
 21 actuarial data and financial information used to prepare the
 22 initial risk sharing valuation study under Section 9B of this
 23 article shall be used to prepare each subsequent risk sharing
 24 valuation study under this section, unless changed based on the
 25 actuarial experience study conducted under Section 9C of this
 26 article.
- 27 (h) The actuarial data provided under Subsection (a)(2) of

- 1 this section may not include the identifying information of
- 2 individual members.
- 3 Sec. 9B. INITIAL RISK SHARING VALUATION STUDIES; CORRIDOR
- 4 MIDPOINT. (a) The pension system and the city shall separately
- 5 prepare an initial risk sharing valuation study that is dated as of
- 6 July 1, 2016, in accordance with this section. An initial risk
- 7 sharing valuation study must:
- 8 (1) except as otherwise provided by this section, be
- 9 prepared in accordance with Section 9A of this article and, for
- 10 purposes of Section 9A(a)(2) of this article, be based on actuarial
- 11 data as of June 30, 2016; and
- 12 (2) project the corridor midpoint for 31 fiscal years
- 13 beginning with the fiscal year beginning July 1, 2017.
- 14 (b) If the action was not taken before the year 2017
- 15 effective date, as soon as practicable after the year 2017
- 16 effective date:
- 17 (1) the pension system shall provide to the city
- 18 actuary, under a confidentiality agreement, the actuarial data
- 19 needed to prepare the proposed initial risk sharing valuation
- 20 study; and
- 21 (2) not later than the 30th day after the date the
- 22 city's actuary receives the actuarial data:
- (A) the city actuary, at the direction of the
- 24 city, shall provide a proposed initial risk sharing valuation study
- 25 to the pension system actuary; and
- 26 (B) the pension system actuary, at the direction
- 27 of the pension system, shall provide a proposed initial risk

- (c) If, after exchanging proposed initial risk sharing valuation studies under Subsection (b)(2) of this section, it is determined that the difference between the contribution rate for any fiscal year in the proposed initial risk sharing valuation study prepared by the pension system actuary and in the proposed initial risk sharing valuation study prepared by the city actuary is:
- (1) less than or equal to two percentage points, the city contribution rate for that fiscal year as determined by the pension system actuary will be used; or
- (2) greater than two percentage points, the city
 actuary and the pension system actuary shall have 20 business days
 to reconcile the difference and:
- (A) if, as a result of reconciliation efforts
 under this subdivision, the difference in any fiscal year is
 reduced to less than or equal to two percentage points, the city
 contribution rate as determined by the pension system actuary for
 that fiscal year will be used; or
- (B) if, after 20 business days, the city actuary
 and the pension system actuary are not able to reach a
 reconciliation that reduces the difference to an amount less than
 or equal to two percentage points for any fiscal year:
- 27 (i) the city actuary at the direction of the

- 1 city and the pension system actuary at the direction of the pension
- 2 system each shall deliver to the finance director of the city and
- 3 the executive director of the pension system a final initial risk
- 4 sharing valuation study with any agreed-to changes, marked as the
- 5 final initial risk sharing valuation study for each actuary; and
- 6 (ii) the finance director and the executive
- 7 director shall execute a joint addendum to the final initial risk
- 8 sharing valuation study that is a part of each final initial risk
- 9 sharing valuation study for all purposes and that reflects the
- 10 arithmetic average of the city contribution rate for each fiscal
- 11 year in which the difference was greater than two percentage
- 12 points.
- 13 (d) In preparing the initial risk sharing valuation study,
- 14 the city actuary and pension system actuary shall:
- 15 (1) adjust the actuarial value of assets to be equal to
- 16 the current market value of assets;
- 17 (2) assume the issuance of planned pension obligation
- 18 bonds by December 31, 2017; and
- 19 (3) assume benefit and contribution changes
- 20 contemplated by this article as of the year 2017 effective date.
- 21 (e) If the city actuary does not prepare an initial risk
- 22 sharing valuation study for purposes of this section, the pension
- 23 system actuary's initial risk sharing valuation study will be used
- 24 as the final risk sharing valuation study for purposes of this
- 25 article unless the city did not prepare a proposed initial risk
- 26 sharing valuation study because the pension system actuary did not
- 27 provide the necessary actuarial data in a timely manner. If the

- 1 city did not prepare a proposed initial risk sharing valuation
- 2 study because the pension system actuary did not provide the
- 3 necessary actuarial data in a timely manner, the city actuary shall
- 4 have 60 days to prepare the proposed initial risk sharing valuation
- 5 study on receipt of the necessary information.
- 6 (f) If the pension system actuary does not prepare a
- 7 proposed initial risk sharing valuation study for purposes of this
- 8 section, the proposed initial risk sharing valuation study prepared
- 9 by the city actuary will be the final risk sharing valuation study
- 10 for purposes of this article.
- 11 (g) The city and the board may agree on a written transition
- 12 plan for resetting the corridor midpoint:
- (1) if at any time the funded ratio is equal to or
- 14 greater than 100 percent; or
- 15 (2) for any fiscal year after the payoff year of the
- 16 legacy liability.
- 17 (h) If the city and the board have not entered into an
- 18 agreement described by Subsection (g) of this section in a given
- 19 fiscal year, the corridor midpoint will be the value determined in
- 20 the initial risk sharing valuation study prepared in accordance
- 21 with this section.
- (i) If the city makes a contribution to the pension system
- 23 of at least \$5 million more than the amount that would be required
- 24 by Section 9(a) of this article, a liability gain layer with the
- 25 same remaining amortization period as the legacy liability is
- 26 created and the corridor midpoint shall be decreased by the
- 27 amortized amount in each fiscal year covered by the liability gain

- 1 layer produced divided by the projected pensionable payroll.
- 2 (j) If the city fails to pay to the pension system the
- 3 proceeds of pension obligation bonds by December 31, 2017, the risk
- 4 sharing valuation study prepared for the fiscal year ending June
- 5 30, 2019, must reflect:
- 6 (1) a city contribution rate adjusted to the corridor
- 7 midpoint for the remaining amortization period for the legacy
- 8 liability to account for the actual delivery date of any bond
- 9 proceeds or for the undelivered bond proceeds;
- 10 (2) credit for amounts actually paid and amortizing
- 11 any unpaid amounts over the remaining amortization period for the
- 12 legacy liability; and
- 13 (3) for purposes of this article, the resulting
- 14 corridor midpoint for each year shall be considered the corridor
- 15 midpoint established for that year in the initial risk sharing
- 16 <u>valuation study</u>.
- 17 Sec. 9C. ACTUARIAL EXPERIENCE STUDIES. (a) At least once
- 18 every four years, the pension system actuary at the direction of the
- 19 pension system shall conduct an actuarial experience study. The
- 20 actuarial experience study required by this subsection must be
- 21 completed not later than September 30 of the year in which the study
- 22 is required to be conducted.
- 23 (b) Except as otherwise expressly provided by Section 9A of
- 24 this article, actuarial assumptions and methods used in the
- 25 preparation of a risk sharing valuation study, other than the
- 26 initial risk sharing valuation study, shall be based on the results
- 27 of the most recent actuarial experience study.

- 1 (c) Not later than the 180th day before the date the board
- 2 may consider adopting any assumptions and methods for purposes of
- 3 Section 9A of this article, the pension system shall provide the
- 4 city actuary with a substantially final draft of the pension
- 5 system's actuarial experience study, including:
- 6 (1) all assumptions and methods recommended by the
- 7 pension system's actuary; and
- 8 (2) summaries of the reconciled actuarial data used in
- 9 creation of the actuarial experience study.
- 10 (d) Not later than the 60th day after the date the city
- 11 receives the final draft of the pension system's actuarial
- 12 experience study under Subsection (c) of this section, the city
- 13 actuary and pension system actuary shall confer and cooperate on
- 14 reconciling and producing a final actuarial experience study.
- 15 During the period prescribed by this subsection, the pension system
- 16 <u>actuary may modify the recommended assumptions in the draft</u>
- 17 actuarial experience study to reflect any changes to assumptions
- 18 and methods to which the pension system actuary and the city actuary
- 19 agree.
- 20 (e) At the city actuary's written request, the pension
- 21 system shall provide additional actuarial data used by the pension
- 22 system actuary to prepare the draft actuarial experience study,
- 23 provided that confidential data may only be provided subject to a
- 24 confidentiality agreement in which the city actuary agrees to
- 25 comply with the confidentiality provisions of Section 29 of this
- 26 article.
- 27 (f) The city actuary at the direction of the city shall

- 1 provide in writing to the pension system actuary and the pension
- 2 system:
- 3 (1) any assumptions and methods recommended by the
- 4 city actuary that differ from the assumptions and methods
- 5 recommended by the pension system actuary; and
- 6 (2) the city actuary's rationale for each method or
- 7 <u>assumption the actuary recommends and determines to be consistent</u>
- 8 with standards adopted by the Actuarial Standards Board.
- 9 (g) Not later than the 30th day after the date the pension
- 10 system actuary receives the city actuary's written recommended
- 11 assumptions and methods and rationale under Subsection (f) of this
- 12 section, the pension system shall provide a written response to the
- 13 city actuary identifying any assumption or method recommended by
- 14 the city actuary that the pension system does not accept. If any
- 15 assumption or method is not accepted, the pension system shall
- 16 recommend to the city the names of three independent actuaries for
- 17 purposes of this section.
- (h) An actuary may only be recommended, selected, or engaged
- 19 by the pension system as an independent actuary under this section
- 20 if the person:
- 21 (1) is not already engaged by the city, the pension
- 22 system, or any other <u>fund or pension</u> system authorized under
- 23 Article 6243e.2(1), Revised Statutes, or Chapter 88 (H.B. 1573),
- 24 Acts of the 77th Legislature, Regular Session, 2001 (Article 6243h,
- 25 <u>Vernon's Texas Civil Statutes</u>), to provide actuarial services to
- 26 the city, the pension system, or another fund or pension system;
- 27 (2) is a member of the American Academy of Actuaries;

- 1 and
- 2 (3) has at least five years of experience as an actuary
- 3 working with one or more public retirement systems with assets in
- 4 excess of \$1 billion.
- 5 (i) Not later than the 20th day after the date the city
- 6 receives the list of three independent actuaries under Subsection
- 7 (g) of this section, the city shall identify and the pension system
- 8 shall hire one of the listed independent actuaries on terms
- 9 acceptable to the city and the pension system to perform a scope of

- 4 service credit at a rate of interest equal to 2.75 percent per year.
- 5 The board may adopt rules necessary to implement this section.
- 6 SECTION 2.21. Section 18(a), Article 6243g-4, Revised
- 7 Statutes, is amended to read as follows:
- 8 (a) Except as provided by this section:
- 9 (1) credit may not be allowed to any person for service
- 10 with any department in the city other than the police department;
- 11 [and]
- 12 (2) a person's service will be computed from the date
- 13 of entry into the service of the police department as a classified
- 14 police officer until the date of separation from service with the
- 15 police department; and
- 16 (3) a member who received service credit for service
- 17 with any department in the city other than the police department and

- 19 other person or entity to furnish information the board requires

The city shall provide any information that may be 25

reasonably necessary to enable the pension system to comply with

administrative services the pension system performs for the city as

- 1 reasonably necessary to obtain any ruling or determination letter
- 2 from the Internal Revenue Service.
- 3 (d) The information provided by the city shall be
- 4 transmitted to the pension system electronically in a format
- 5 specified by the pension system, to the extent available to the
- 6 city, or in writing if so requested on behalf of the pension system.
- 7 <u>(e) The pension system shall determine each member's</u>
- 8 credited service and pension benefits on the basis of the personnel
- 9 and financial records of the city and the records of the pension
- 10 system.
- 11 SECTION 2.24. Section 23, Article 6243g-4, Revised
- 12 Statutes, is amended to read as follows:
- 13 Sec. 23. MEMBERS IN MILITARY SERVICE. (a) A member of the
- 14 pension system engaged in active service in a uniformed service may
- 15 not be required to make the monthly payments into the fund and may
- 16 not lose any previous years' service with the city because of the
- 17 uniformed service. The uniformed service shall count as continuous
- 18 service in the police department if the member returns to the city
- 19 police department after discharge from the uniformed service as an
- 20 employee within the period required by the Uniformed Services

- 12 contribution plans in which the member has been a member were
- 13 payable from one plan.
- 14 (h-1) For purposes of adjusting any benefit due to the
- 15 limitations prescribed by Section 415(b) of the code, the following
- 16 provisions shall apply:
- 17 (1) before January 1, 1995, a member may not receive an
- 18 annual benefit that exceeds the limits specified in Section 415(b)
- 19 of the code, subject to the applicable adjustments in that section;
- 20 (2) on and after January 1, 1995, a member may not

- 1 amount determined under Subsection (h-1) of this section, as 2 adjusted under Subsection (h-2) or (h-5) of this section, multiplied by a fraction, the numerator of which is the number of 3 the member's years of participation and the denominator of which is 4 5 10. The limit under Subsection (h-9) of this section concerning the \$10,000 limit shall be similarly reduced for any member who has 6 7 accrued less than 10 years of service, except the fraction shall be determined with respect to years of service instead of years of 8 participation. The reduction provided by this subsection cannot 9 10 reduce the maximum benefit below 10 percent of the limit determined without regard to this subsection. - 23 (h-10) On and after January 1, 1995, for purposes of 24 applying the limits under Section 415(b) of the code to a member's 25 benefit paid in a form to which Section 417(e)(3) of the code does 26 not apply, the following provisions apply:

- 2 without regard to any cost-of-living adjustments under Section 12

- 20 with applicable federal regulations.
- 21 (h-12) Reduction of benefits or contributions to all plans,
- 22 where required, shall be accomplished by:
- 23 (1) first, reducing the member's benefit under any
- 24 defined benefit plans in which the member participated, with the
- 25 reduction to be made first with respect to the plan in which the
- 26 member most recently accrued benefits and then in the priority
- 27 determined by the pension system and the plan administrator of such

- 1 other plans; and
- 2 <u>(2) next, reducing or allocating excess forfeitures</u>
- 3 for defined contribution plans in which the member participated,
- 4 with the reduction to be made first with respect to the plan in
- 5 which the member most recently accrued benefits and then in the

- 8 (h-13) Notwithstanding Subsection (h-12) of this section,

- 12 is to be determined on the basis of actuarial assumptions that are
- 13 not otherwise specifically set forth for that purpose in this

- 8 (j-2) If a majority of the pension board determines that a

- 11 interests of the pension system or is in violation of this Act or
- 12 any agreement between the pension board and the city entered into
- 13 under Section 3(n) of this Act, the pension board may recommend to
- 14 the mayor, controller, or governing body, as appropriate, that the
- 15 appointed trustee be removed from the pension board. If the
- 16 appointed trustee was appointed by the governing body of the city,
- 17 an action item concerning the pension board's recommendation shall

- 24 shall, at the first pension board meeting following the trustee's
- 25 most recent election or appointment, take an oath of office that the

- 2 (2) will not knowingly violate this Act or willingly
- 3 allow a violation of this Act to occur.
- 4 (n) The person serving as a trustee under Subsection (c)(2)

- 22 <u>section shall complete minimum educational training requirements</u>
- 23 established by the State Pension Review Board. The appointing
- 24 entity may remove an appointed trustee who does not complete
- 25 minimum educational training requirements during the period
- 26 prescribed by the State Pension Review Board.
- 27 (gg) The pension board shall adopt an ethics policy

- 1 governing, among other matters, conflicts of interest, including
- 2 standards of ethical conduct and disclosure requirements,
- 3 applicable to:
- 4 (1) trustees;
- 5 <u>(2)</u> employees; and
- 6 (3) any contractors or categories of contractors that
- 7 the pension determines provide:
- 8 (A) any advice or opinion to the pension system
- 9 that is the basis for a significant decision or action by or on
- 10 behalf of the pension system; or
- 11 (B) significant services to the pension system
- 12 that relate to the administration and operation of the pension
- 13 system.
- 14 (hh) During a trustee's term on the pension board and for
- 15 one year after leaving the pension board, a trustee may not
- 16 represent any other person or organization in any formal or
- 17 informal appearance before the pension board or pension system
- 18 staff concerning a matter for which the person has or had
- 19 responsibility as a trustee.
- 20 (ii) The pension board may establish standing or temporary
- 21 committees as necessary to assist the board in carrying out its
- 22 business, including committees responsible for risk management or
- 23 governance, investments, administration and compensation,
- 24 personnel issues, financial and actuarial matters, audits,
- 25 disability determinations, and agreements under Section 3(n) of
- 26 this Act. If the pension board establishes a committee responsible
- 27 for agreements under Section 3(n) of this Act, the committee must be

- 1 a committee of the elected trustees and the trustee appointed by the
- 2 elected trustees. Except for a committee responsible for
- 3 agreements under Section 3(n) of this Act and any committee

- 24 in the pension system's annual reports or valuations.
- 25 (b) When the board retains an independent investment
- 26 consultant under this section, the pension system may require the
- 27 consultant to agree in writing to maintain the confidentiality of:

- 1 (1) information provided to the consultant that is
- 2 reasonably necessary to conduct a review under this section; and
- 3 (2) any nonpublic information provided for the pension
- 4 system for the audit.
- 5 (c) The costs for the investment report required by this
- 6 section shall be paid from the fund.
- 7 SECTION 3.05. Section 3, Chapter 88 (H.B. 1573), Acts of the
- 8 77th Legislature, Regular Session, 2001 (Article 6243h, Vernon's
- 9 Texas Civil Statutes), is amended by amending Subsections (f) and

- (e) At the city actuary's written request, the pension system shall provide additional actuarial data used by the pension system actuary to prepare the draft actuarial experience study, provided that confidential data may only be provided subject to a confidentiality agreement entered into between the pension system and the city actuary.
- (f) The city actuary, at the direction of the city, shall provide in writing to the pension system actuary and the pension system:
- (1) any assumptions and methods recommended by the city actuary that differ from the assumptions and methods recommended by the pension system actuary; and
- 22 (2) the city actuary's rationale for each method or 23 assumption the actuary recommends and determines to be consistent 24 with standards adopted by the Actuarial Standards Board.
- 25 <u>(g) Not later than the 30th day after the date the pension</u>
 26 <u>system actuary receives the city actuary's written recommended</u>
 27 assumptions and methods and rationale under Subsection (f) of this

- 1 section, the pension system shall provide a written response to the
- 2 city actuary identifying any assumption or method recommended by
- 3 the city actuary that the pension system does not accept. If any

- 12 ARTICLE 5. CONFLICTING LEGISLATION; EFFECTIVE DATE
- 13 SECTION 5.01. If this Act conflicts with any other Act of
- 14 the 85th Legislature, Regular Session, 2017, this Act controls
- 15 unless the conflict is expressly resolved by the legislature by
- 16 reference to this Act.
- 17 SECTION 5.02. Except as otherwise provided by this Act,
- 18 this Act takes effect immediately if it receives a vote of
