1-15 A BILL TO BE ENTITLED
1-16 AN ACT

1-17 relating to the name of the Burnet County Municipal Utility
1-18 District No. 1.

1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. The heading to Chapter 7913, Special District
1-21 Local Laws Code, is amended to read as follows:

1-22 CHAPTER 7913. HIGHWAY 71 [BURNET COUNTY] MUNICIPAL UTILITY
1-23 DISTRICT [NO. 1]

1-24 SECTION 2. Section 7913.001(4), Special District Local Laws
1-25 Code, is amended to read as follows:

1-26 (4) "District" means the Highway 71 [Burnet County]
1-27 Municipal Utility District [No. 1].

1-28 SECTION 3. (a) The legislature validates and confirms the
1-29 creation of the Highway 71 Municipal Utility District and all acts
1-30 and proceedings of the district under that name or as the Burnet
1-31 County Municipal Utility District No. 1 that were taken before the
1-32 effective date of this Act, including all elections conducted by
1-33 the district.

1-34 (b) Subsection (a) of this section does not apply to any
1-35 matter that on the effective date of this Act:

1-36 (1) is involved in litigation if the litigation
1-37 ultimately results in the matter being held invalid by a final
1-38 judgment of a court; or

1-39 (2) has been held invalid by a final judgment of a
1-40 court.

1-41 SECTION 4. A reference in law to the Burnet County Municipal
1-42 Utility District No. 1 means the Highway 71 Municipal Utility
1-43 District.

1-44 SECTION 5. This Act takes effect immediately if it receives
1-45 a vote of two-thirds of all the members elected to each house, as
1-46 provided by Section 39, Article III, Texas Constitution. If this
1-47 Act does not receive the vote necessary for immediate effect, this
1-48 Act takes effect September 1, 2017.
