A BILL TO BE ENTITLED AN ACT

1**-**17 1**-**18 relating to the boundaries of the Harris County Fresh Water Supply District No. 58. 1-19

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. DEFINITION. In this Act, "district" means the Harris County Fresh Water Supply District No. 58. SECTION 2. EXCLUSION OF TERRITORY. The boundaries of the district are adjusted to exclude the following parcel of land: 1-20 1-21

APPORTIONMENT OF DISTRICT 3-1 SECTION 4. INDEBTEDNESS. (a) The excluded property is not released from the payment of its 3-2 pro rata share of the district's indebtedness. 3-3

3-4 (b) The district shall continue to levy taxes each year on the property excluded from the district at the same rate levied on other property of the district until the taxes collected from the excluded property equal the property's pro rata share of the 3-5 3-6 3-7 indebtedness of the district on the effective date of this Act. The 3-8 3-9 taxes collected shall be applied exclusively to the payment of the 3-10 3-11

excluded property's pro rata share of the indebtedness. (c) The owner of any part of the excluded property at any time may pay in full the owner's share of the pro rata share of the 3-12 3-13 indebtedness of the district.

3-14 SECTION 5. NOTICE. (a) The legal notice of the intention 3**-**15 3**-**16 to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, 3-17 officials, or entities to which they are required to be furnished 3-18 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 3-19 3-20 3-21 Government Code.

The governor, one of the required recipients, has the notice and Act to the Texas Commission on (b) 3-22 submitted Environmental Quality. 3-23

3-24 (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of 3-25 3**-**26 the speaker lieutenant governor, and 3-27 representatives within the required time.

3-28 (d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect 3-29 3-30 to the notice, introduction, and passage of this Act are fulfilled 3-31 and accomplished.

3-32 SECTION 6. EFFECTIVE DATE. This Act takes effect immediately if it receives a vote of two-thirds of all the members 3-33 3-34 elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017. 3-35 3-36
