TCOLE Mission




The Texas Commission on Law Enforcement (TCOLE) is a state agency charged with five primary responsibilities:

- Establishing minimum standards to obtain and maintain a peace officer, county jailer, telecommunicator, or school marshal license, and issuing licenses to qualified applicants;
- Overseeing basic training and continuing education requirements to maintain an active license;
- Taking enforcement action against licenses in the event of criminal or administrative violations;
- Auditing law enforcement agencies and training providers for compliance with hiring standards and providing technical assistance; and
- Approving the creation of new law enforcement agencies that meet minimum standards established by the Legislature.






Current Staff Breakdown





Field Services



- TCOLE Field Service Agents provide on-site audits of all 2,654 law enforcement agencies, as well as valuable technical assistance.
- Field Services audited:
 - 848 agencies and academies in FY 15
 - 942 agencies and academies in FY 16

Enforcement



- The TCOLE Enforcement Division conducts both criminal and administrative investigations.
- Since last session:
 - 758 cases opened in FY 15
 - 550 cases closed in FY 15
 - 1,291 cases opened in FY 16
 - 713 cases closed in FY 16


The TCOLE Special Services Division serves several functions:

- Maintenance of the Texas Commission on Law Enforcement Data Distribution System (TCLEDDS)
- Managing and maintaining TCOLE's network and website
- Overseeing curriculum and mandated course material
- Managing online training courses through MyTCOLE site:
 - FY 15: 49,256 courses taken
 - FY 16: 42,890 courses taken
- Criminal history checks for academy applicants and license reinstatement
- New agency creation and inspection
 - FY 15: 32
 - FY 16: 23
