1-17 A BILL TO BE ENTITLED
 1-18 AN ACT

1-19 relating to disaster preparation for state agencies and political
 1-20 subdivisions.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Subchapter B, Chapter 418, Government Code, is
 1-23 amended by adding Section 418.0155 to read as follows:

1-24 Sec. 418.0155. SUSPENSION LIST. (a) The governor's
 1-25 office, using existing resources, shall compile and maintain a
 1-26 comprehensive list of regulatory statutes and rules that may
 1-27 require suspension during a disaster.

1-28 (b) On request by the governor's office, a state agency that
 1-29 would be impacted by the suspension of a statute or rule on the list
 1-30 compiled under Subsection (a) shall review the list for accuracy
 1-31 and shall advise the governor's office regarding any statutes or
 1-32 rules that should be added to the list.

1-33 SECTION 2. Subchapter C, Chapter 418, Government Code, is
 1-34 amended by adding Section 418.054 to read as follows:

1-35 Sec. 418.054. DISASTER PREPARATION CONTRACTS. (a) The
 1-36 division, in consultation with other state agencies the division
 1-37 considers appropriate, shall develop a plan to assist political
 1-38 subdivisions of this state with executing contracts for services
 1-39 that political subdivisions are likely to need following a
 1-40 disaster. The plan must include:

1-41 (1) training on the benefits to a political
 1-42 subdivision from executing disaster preparation contracts in
 1-43 advance of a disaster;

1-44 (2) recommendations on the services political
 1-45 subdivisions are likely to need following a disaster, including
 1-46 debris management and infrastructure repair; and

1-47 (3) assistance to political subdivisions with finding
 1-48 persons capable of providing the services described by Subdivision
 1-49 (2) and executing contracts with those persons in advance of a
 1-50 disaster.

1-51 (b) The division shall consult with the comptroller
 1-52 regarding including a contract for services a political subdivision
 1-53 is likely to need following a disaster, including debris management
 1-54 and infrastructure repair, on the schedule of multiple award
 1-55 contracts developed under Subchapter I, Chapter 2155, or as part of
 1-56 another cooperative purchasing program administered by the
 1-57 comptroller.

1-58 SECTION 3. This Act takes effect September 1, 2019.
