1-19 relating to the online publication of home addresses of certain
 1-20 occupational license holders.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Subchapter B, Chapter 403, Occupations Code, is
 1-23 amended by adding Section 403.053 to read as follows:

1-24 Sec. 403.053. PUBLISHING LICENSE HOLDER HOME ADDRESS
 1-25 PROHIBITED. (a) The department may not include the home address of
 1-26 a person licensed under this chapter in a roster, registry, or other
 1-27 database the department publishes on the department's Internet
 1-28 website unless the person requests that the person's home address
 1-29 appear in the roster, registry, or other database on the website. A
 1-30 request under this subsection must be made in the manner prescribed
 1-31 by the department.

1-32 (b) The home address of a person licensed under this chapter
 1-33 that is included in a roster, registry, or other database the
 1-34 department maintains is public information and is not excepted from
 1-35 required disclosure under Chapter 552, Government Code.

1-36 SECTION 2. Section 503.207, Occupations Code, is amended by
 1-37 adding Subsections (c) and (d) to read as follows:

1-38 (c) The board may not include the home address of a person
 1-39 licensed under this chapter in a registry the board publishes on the
 1-40 board's Internet website unless the person requests that the
 1-41 person's home address appear in the registry on the website. A
 1-42 request under this subsection must be made in the manner prescribed
 1-43 by the board.

1-44 (d) The home address of a person licensed under this chapter
 1-45 that is included in the registry the board prepares under this
 1-46 section is public information and is not excepted from required
 1-47 disclosure under Chapter 552, Government Code.

1-48 SECTION 3. Section 504.055, Occupations Code, is amended by
 1-49 adding Subsections (e) and (f) to read as follows:

1-50 (e) The department may not include the home address of a
 1-51 person licensed by the department in a roster the department
 1-52 publishes on the department's Internet website unless the person
 1-53 requests that the person's home address appear in the roster on the
 1-54 website. A request under this subsection must be made in the manner
 1-55 prescribed by the department.

1-56 (f) The home address of a person licensed under this chapter
 1-57 that is included in a roster the department prepares under this
 1-58 section is public information and is not excepted from required
 1-59 disclosure under Chapter 552, Government Code.

1-60 SECTION 4. Section 505.205, Occupations Code, is amended by
 1-61 adding Subsections (d) and (e) to read as follows:
