BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Article 49.17, Code of Criminal Procedure, is amended to read as follows: 1-21

1-22 1-23 Art. 49.17. EVIDENCE. A justice of the peace shall preserve all tangible evidence that the justice accumulates in the course of an inquest that tends to show the real cause of death or identify 1-24 1-25 the person who caused the death. The justice shall [+

[(1)] deposit the evidence with the appropriate law 1-26 1-27 1-28 enforcement agency to be stored in the agency's property room for safekeeping[; or

 $\left[\frac{(2)}{(2)}\right]$ 1-29 deliver the evidence to the district clerk for 1-30 safekeeping subject to the order of the court].

1-31 SECTION 2. Article 49.15(d), Code of Criminal Procedure, is 1-32 repealed.
