- 2 relating to the establishment of the Texas Pay Equity Task Force.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. (a) In this section, "task force" means the
- 5 Texas Pay Equity Task Force.
- 6 (b) The Texas Pay Equity Task Force is established to assess
- 7 whether a disparity exists on the basis of gender or race in
- 8 compensation paid to employees of state agencies, counties, and
- 9 municipalities.
- 10 (c) The task force is composed of nine members appointed as
- 11 follows:
- 12 (1) two representatives of state agencies and one
- 13 representative of a nonprofit organization engaged in race or
- 14 gender pay equity issues, appointed by the governor;
- 15 (2) one representative of a county, one representative
- 16 of a municipality, and one representative of a nonprofit
- 17 organization engaged in race or gender pay equity issues, appointed
- 18 by the lieutenant governor; and
- 19 (3) one representative of a county, one representative
- 20 of a municipality, and one representative of a nonprofit
- 21 organization engaged in race or gender pay equity issues, appointed
- 22 by the speaker of the house of representatives.
- 23 (d) A task force member is not entitled to compensation for
- 24 service on the task force but is entitled to reimbursement for

- 1 actual and necessary expenses incurred in performing task force
- 2 duties. The task force may accept gifts, grants, and donations to
- 3 pay for those expenses.
- 4 (e) The members of the task force shall elect a presiding
- 5 officer from among the membership.
- 6 (f) The task force shall meet at least quarterly at the call
- 7 of the presiding officer.
- 8 (g) Notwithstanding Chapter 551, Government Code, or any
- 9 other law, the task force may meet by telephone conference call,
- 10 videoconference, or other similar telecommunication method. A
- 11 meeting held by telephone conference call, videoconference, or
- 12 other similar telecommunication method is subject to the
- 13 requirements of Sections 551.125(c), (d), (e), and (f), Government
- 14 Code.
- 15 (h) The task force shall conduct a study to determine
- 16 whether a disparity exists on the basis of gender or race in
- 17 compensation paid to employees of state agencies, counties, and
- 18 municipalities. The task force may request payroll information,
- 19 including the gender and race of each employee, from a state agency,
- 20 county, or municipality, and the state agency, county, or
- 21 municipality shall comply with the request.
- (i) If the task force determines that a pay disparity
- 23 exists, the task force shall develop recommendations to eliminate
- 24 the disparity.
- 25 (j) The task force shall develop and submit a written report
- 26 on the study and recommendations developed by the task force to the
- 27 governor, the lieutenant governor, the speaker of the house of

- 2 November 1, 2020.
- 3 (k) The task force is abolished and this Act expires June 1,
- 4 2021.
- 5 SECTION 2. This Act takes effect immediately if it receives
- 6 a vote of two-thirds of all the members elected to each house, as
- 7 provided by Section 39, Article III, Texas Constitution. If this
- 8 Act does not receive the vote necessary for immediate effect, this
- 9 Act takes effect September 1, 2019.
