## A BILL TO BE ENTITLED

4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 29.906, Education Code, is amended to
6	read as follows:
7	Sec. 29.906. CHARACTER TRAITS INSTRUCTION [EDUCATION
8	PROGRAM]. (a) The State Board of Education shall integrate
9	positive character traits into the essential knowledge and skills
10	adopted for kindergarten through grade 12, as appropriate [A school
11	district may provide a character education program].
12	(b) The State Board of Education must include the following
13	[A character education program under this section must:
14	[ <del>(1) stress</del> ] positive character traits [ <del>, such as</del> ]:
15	<u>(1)</u> [ <del>(A)</del> ] courage;
16	(2) [ $(B)$ ] trustworthiness, including honesty,
17	reliability, punctuality, and loyalty;
18	(3) [(C)] integrity;
19	(4) [ $(D)$ ] respect and courtesy;
20	(5) [ $(E)$ ] responsibility, including accountability,
21	diligence, perseverance, and self-control;
22	$\overline{(6)}$ [ $\overline{(F)}$ ] fairness, including justice and freedom
23	from prejudice;
24	(7) [ $(G)$ ] caring, including kindness, empathy,

- 2 (8) [<del>(H)</del>] good citizenship, including patriotism,
- 3 concern for the common good and the community, and respect for
- 4 authority and the law; [and]
- 5 (9)  $[\frac{1}{1}]$  school pride; and
- 6 <u>(10) gratitude</u>[+
- 7 [(2) use integrated teaching strategies; and
- 8 [<del>(3) be age appropriate</del>].
- 9 (c) The State Board of Education shall create a report that
- 10 identifies the manner in which the character traits listed under
- 11 Subsection (b) have been integrated into the curriculum. The board
- 12 shall make the report publicly available on the board's Internet
- 13 website.
- 14 (d) Each school district and open-enrollment charter school
- 15 must adopt a character education program that includes the positive
- 16 character traits listed in Subsection (b). The district or
- 17 open-enrollment charter school shall submit the adopted program to
- 18 the agency annually, in a manner determined by the commissioner.
- 19 (e) In developing or selecting a character education
- 20 program under this section, a school district shall consult with a
- 21 committee selected by the district that consists of:
- 22 (1) parents of district students;
- 23 (2) educators; and
- 24 (3) other members of the community, including
- 25 community leaders.
- 26 (f) [<del>(d)</del>] This section does not require or authorize
- 27 proselytizing or indoctrinating concerning any specific religious

- 2 (g)  $[\frac{(e)}{(e)}]$  The agency shall:
- 3 (1) maintain a list of character education programs
- 4 that school districts have implemented that meet the criteria under
- 5 Subsection (b); and
- 6 (2) using the services of a center for education
- 7 research established under Section 1.005, and based on data
- 8 reported by districts, annually designate as a Character Plus
- 9 School each school that provides a character education program
- 10 that:
- 11 (A) meets the criteria prescribed by Subsection
- 12 (b); [and]
- 13 (B) is approved by the committee selected under
- 14 Subsection (e) [(c)]; and
- (C) demonstrates a correlation between the
- 16 character education program adopted by the school, an increase in
- 17 student attendance levels, and a decrease in student disciplinary
- 18 problems [(3) include in the report required under Section 39.332:
- 19 [(A) based on data reported by districts, the
- 20 impact of character education programs on student discipline and
- 21 academic achievement; and
- 22 [(B) other reported data relating to character
- 23 education programs the agency considers appropriate for

- (h)  $[\frac{f}{f}]$  The agency may accept money from  $[\frac{federal}{f}]$
- 26 government and] private sources to use in assisting school
- 27 districts in implementing character education programs that meet

- 1 the criteria prescribed by Subsection (b).
- 2 <u>(i) The State Board of Education may adopt rules as</u>
- 3 necessary to implement this section.
- 4 SECTION 2. This Act applies beginning with the 2019-2020
- 5 school year.
- 6 SECTION 3. This Act takes effect immediately if it receives
- $7\,$  a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2019.
