 1-18 AN ACT

1-19 relating to the authority of certain county assistance districts to
 1-20 provide a grant or loan.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Section 387.006(a), Local Government Code, is
 1-23 amended to read as follows:

1-24 (a) A district may:

1-25 (1) perform any act necessary to the full exercise of
 1-26 the district's functions;

1-27 (2) accept a grant or loan from:

1-28 (A) the United States;

1-29 (B) an agency or political subdivision of this
 1-30 state; or

1-31 (C) a public or private person;

1-32 (3) acquire, sell, lease, convey, or otherwise dispose
 1-33 of property or an interest in property under terms determined by the
 1-34 district;

1-35 (4) employ necessary personnel;

1-36 (5) adopt rules to govern the operation of the
 1-37 district and its employees and property; ~~and~~

1-38 (6) enter into agreements with municipalities
 1-39 necessary or convenient to achieve the district's purposes,
 1-40 including agreements regarding the duration, rate, and allocation
 1-41 between the district and the municipality of sales and use taxes;
 1-42 and

1-43 (7) if the district is created by a county with a
 1-44 population of more than 580,000 that borders a county with a
 1-45 population of more than four million, provide a grant or loan to a
 1-46 political subdivision to assist in funding the performance of one
 1-47 or more functions a district is authorized to perform under this
 1-48 chapter.

1-49 SECTION 2. This Act takes effect September 1, 2019.
