6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Chapter 38, Education Code, is amended by adding
8	Subchapter B-1 to read as follows:
9	SUBCHAPTER B-1. SCHOOL-BASED BEHAVIORAL HEALTH CENTERS
10	Sec. 38.081. DEFINITIONS. In this subchapter:
11	(1) "Behavioral health services" includes mental
12	health assessments, crisis interventions, counseling, mental
13	health treatments and referrals to a continuum of mental health
14	services, including psychiatric care, community support programs,
15	and inpatient or outpatient care programs.
16	(2) "Executive commissioner" means the executive
17	commissioner of the Health and Human Services Commission.
18	Sec. 38.082. ESTABLISHMENT OF SCHOOL-BASED BEHAVIORAL
19	HEALTH CENTER. (a) A school district may establish a school-based
20	behavioral health center to:
21	(1) provide accessible behavioral health services to

students and their families;

4	(b) A school district may combine a school-based behavioral
5	health center with a school-based health center established under
6	Subchapter B or any other district program that provides primary
7	health care services to students.
8	Sec. 38.083. CENTER REQUIREMENTS. (a) A school-based
9	behavioral health center must:
10	(1) be located at or near a school district facility;
11	(2) be organized with assistance from the community
12	and relevant health care providers; and
13	(3) provide behavioral health services during school
14	hours to students in accordance with:
15	(A) applicable federal, state, and local laws;
16	(B) established behavioral health standards; and
17	(C) community practice.
18	(b) A school-based behavioral health center must be
19	administered by an eligible entity. An eligible entity must be a
20	<pre>community-based organization that is:</pre>
21	(1) a school district;
22	(2) a hospital;
23	(3) a local health department;
24	(4) a federally qualified health center, as defined by
25	42 U.S.C. Section 1396d(1)(2)(B);
26	(5) a community mental health center, as defined by 42
27	U.S.C. Section 1395x(ff)(3)(B);

1	(6) a local mental health authority;
2	(7) a health care provider whose sole purpose is
3	providing school-based behavioral health services; or
4	(8) any other appropriate nonprofit health care agency
5	or behavioral health care agency.
6	Sec. 38.084. GRANTS. (a) The executive commissioner shall
7	administer a program under which grants are awarded to assist
8	school districts with the costs of operating school-based
9	behavioral health centers.
10	(b) To be eligible to receive a grant under this section, a
11	<pre>school district must:</pre>
12	(1) establish or propose to establish a school-based
13	behavioral health center that meets the requirements under Section
14	<u>38.083;</u>
15	(2) provide sufficient information establishing local
16	need for the behavioral health services provided by or proposed to
17	be provided by the center;
18	(3) provide sufficient evidence that:
19	(A) the center will obtain parental consent
20	before providing behavioral health services to children;
21	(B) the district will establish and maintain
22	relationships with health care providers in the district;
23	(C) the center will offer:
24	(i) on-site access during each
25	instructional day; and
26	(ii) 24-hour coverage through an on-call

1	(D) the center will be integrated into the school
2	environment and will coordinate behavioral health resources with
3	district educators and other appropriate support personnel,
4	including other school-based health care providers; and
5	(E) the entity administering the center will
6	assume all responsibility for the administration, operation, and
7	oversight of the center; and
8	(4) provide any other information the executive
9	commissioner determines necessary.
10	(c) In awarding grants under this section, the executive
11	commissioner shall give priority to school districts that seek
12	funding for a school-based behavioral health center that meets at
13	<pre>least two of the following criteria:</pre>
14	(1) the center has already been established;
15	(2) the center will be established at a campus that
16	does not currently have a school-based behavioral health center;
17	(3) the center serves or will serve an area in which
18	there are barriers to students accessing behavioral health
19	services; or
20	(4) the center serves or will serve a campus at which
21	50 percent or more of the students in daily attendance at the campus
22	are:
23	(A) uninsured, underinsured, or enrolled in a
24	<pre>public health insurance program; or</pre>
25	(B) educationally disadvantaged.
26	(d) The executive commissioner shall determine the amount
27	of each grant awarded under this section. In determining the amount

1 of a grant, the executive commissioner shall consider: 2 (1) the financial need of the school district to 3 operate the school-based behavioral health center; 4 (2) other funding provided to the school district for 5 the operation of the center; and 6 (3) any other factor the executive commissioner determines re<u>levant</u>. 7 8 (e) A grant awarded under this section may be used only for: 9 (1) the salaries of health care providers who provide behavioral health services through the school-based behavioral 10 11 health center; 12 (2) overhead costs of the center; or 13 (3) costs related to managing the center's programs. 14 (f) The executive commissioner shall provide to a school 15 district that receives a grant under this section: 16 (1) technical assistance; 17 (2) fiscal and program management assistance and 18 training; 19 (3) operational and administrative support; and 20 (4) information on best practices in offering behavioral health services through a school-based behavioral 21 22 health center. (g) The executive commissioner shall adopt rules as 23 24 necessary to implement this section, including rules regarding the

evaluation and monitoring of school-based behavioral health

centers operated by school districts that receive a grant under

this section.

- 1 SECTION 2. This Act applies beginning with the 2019-2020
- 2 school year.
- 3 SECTION 3. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2019.
