1-17 A BILL TO BE ENTITLED
 1-18 AN ACT

1-19 relating to training and development activities for persons who may
 1-20 interact with an individual with autism or other pervasive
 1-21 developmental disorder.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Section [114.013](#), Human Resources Code, is
 1-24 amended by amending Subsection (b) and adding Subsections (c) and
 1-25 (d) to read as follows:

1-26 (b) As part of coordinating resources under Subsection (a),
 1-27 the commission shall:

1-28 (1) collect and distribute information and research
 1-29 regarding autism and other pervasive developmental disorders;

1-30 (2) conduct training and development activities for
 1-31 persons who may interact with an individual with autism or another
 1-32 pervasive developmental disorder in the course of their employment,
 1-33 including school, medical, and [ex] law enforcement personnel, and
 1-34 personnel of the Department of Family and Protective Services;

1-35 (3) coordinate with local entities that provide
 1-36 services to an individual with autism or another pervasive
 1-37 developmental disorder; and

1-38 (4) provide support for families affected by autism
 1-39 and other pervasive developmental disorders.

1-40 (c) The commission shall ensure that training and
 1-41 development activities under this section are:

1-42 (1) evidenced-based;

1-43 (2) applicable to the professional role of each type
 1-44 of personnel to be trained under Subsection (b)(2); and

1-45 (3) instructive regarding means of effectively
 1-46 communicating and engaging with individuals with limited social or
 1-47 verbal abilities.

1-48 (d) At least once every five years, in consultation with an
 1-49 institution of higher education, the commission shall revise the
 1-50 materials and methods for the training and development activities
 1-51 to be provided under Subsection (b)(2).

1-52 SECTION 2. Not later than September 1, 2024, the executive
 1-53 commissioner of the Health and Human Services Commission shall
 1-54 revise the materials and methods for the training and development
 1-55 activities to be provided under Section [114.013](#)(b)(2), Human
 1-56 Resources Code, as amended by this Act.

1-57 SECTION 3. This Act takes effect September 1, 2019.
