SECTION 1. Subchapter E, Chapter 54, Education Code, amended by adding Section 54.53971 to read as follows: 1-22 is 1**-**23

1-24 Sec. 54.53971. INTERCOLLEGIATE ATHLETICS FEES; TEXAS A&M UNIVERSITY--SAN ANTONIO. (a) The board of regents of The Texas A&M 1-25 University System may impose on each student enrolled at Texas A&M University--San Antonio an intercollegiate athletics fee in an amount not to exceed \$10 per semester credit hour for each regular 1-26 1-27 1-28 semester or summer session unless the amount of the fee is increased 1-29 as provided by Subsection (c). 1-30

(b) The fee may not be imposed unless approved by a majority vote of the students of the university who participate in a general student election held for that purpose. 1-31 1-32 1-33
