BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 14, Chapter 273, Acts of the 55th Legislature, Regular Session, 1957, is amended to read as follows: Sec. 14. (a) The Board of Directors of the Authority <u>is</u> composed [shall be comprised] of eight persons who serve staggered, 1-20 1-21

(b) [Immediately after this Act becomes effective, the following named persons shall be the directors of the Authority and shall constitute the Board of Directors of said Authority:

1-54 (b) A director of the Elm Creek Watershed Authority elected 1-55 in 2018 shall serve until the director's successor has qualified following the directors' election held on the uniform election date 1-56 1-57 in November 2021.
