1-17 A BILL TO BE ENTITLED  
 1-18 AN ACT

1-19 relating to the regulation of salvage vehicle dealers.

1-20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-21 SECTION 1. Subchapter A, Chapter 2302, Occupations Code, is  
 1-22 amended by adding Section 2302.009 to read as follows:

1-23 Sec. 2302.009. APPLICABILITY OF CHAPTER TO CERTAIN GENERAL  
 1-24 DISTINGUISHING NUMBER HOLDERS. This chapter applies to the holder  
 1-25 of an independent motor vehicle dealer's general distinguishing  
 1-26 number issued under Chapter 503, Transportation Code, in the same  
 1-27 manner as this chapter applies to a salvage vehicle dealer if the  
 1-28 holder of the general distinguishing number:

- 1-29 (1) acts as a salvage vehicle dealer or rebuilder; or
- 1-30 (2) stores or displays a motor vehicle as an agent or
- 1-31 escrow agent of an insurance company.

1-32 SECTION 2. Section 2302.101, Occupations Code, is amended  
 1-33 to read as follows:

1-34 Sec. 2302.101. LICENSE OR DEALER'S GENERAL DISTINGUISHING  
 1-35 NUMBER REQUIRED [FOR SALVAGE VEHICLE DEALER]. Unless a person  
 1-36 holds a salvage vehicle dealer license issued under this chapter or  
 1-37 an independent motor vehicle dealer's general distinguishing  
 1-38 number issued under Chapter 503, Transportation Code, the person  
 1-39 may not:

- 1-40 (1) act as a salvage vehicle dealer or rebuilder; or
- 1-41 (2) store or display a motor vehicle as an agent or
- 1-42 escrow agent of an insurance company.

1-43 SECTION 3. This Act takes effect September 1, 2019.
