- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 ARTICLE 1. ENTITIES GIVEN 2021 SUNSET DATE
- 6 SECTION 1.01. TEXAS A&M FOREST SERVICE. Section 88.1016,
- 7 Education Code, is amended to read as follows:
- 8 Sec. 88.1016. SUNSET PROVISION. The Texas A&M Forest
- 9 Service is subject to Chapter 325, Government Code (Texas Sunset
- 10 Act). Unless continued in existence as provided by that chapter,
- 11 the Texas A&M Forest Service is abolished September 1, 2021 [2023].
- 12 SECTION 1.02. TEACHER RETIREMENT SYSTEM OF TEXAS. Section
- 13 825.006, Government Code, is amended to read as follows:
- 14 Sec. 825.006. SUNSET PROVISION. The board of trustees of
- 15 the Teacher Retirement System of Texas is subject to review under
- 16 Chapter 325 (Texas Sunset Act), but is not abolished under that
- 17 chapter. The board shall be reviewed during the period in which
- 18 state agencies abolished in 2021 [2025], and every 12th year after
- 19 that year, are reviewed.

- 13 SECTION 2.01. LIMITED REVIEW OF THE DEPARTMENT OF FAMILY
- 14 AND PROTECTIVE SERVICES. Section 531.0206(a), Government Code, is
- 15 amended to read as follows:
- 16 (a) The Sunset Advisory Commission shall conduct a
- 17 limited-scope review of the commission during the state fiscal
- 18 biennium ending August 31, 2023, in the manner provided by Chapter

- 3 pension system is subject to review under Chapter 325 (Texas Sunset

- 6 be abolished in 2029 [2025], and every 12th year after that year,
- 7 are reviewed.
- 8 ARTICLE 6. ENTITIES REMOVED FROM SPECIFIC SUNSET REVIEW
- 9 SECTION 6.01. REGIONAL EDUCATION SERVICE CENTERS. The
- 10 following laws are repealed:
- 11 (1) Section 8.010, Education Code; and
- 12 (2) Section 2(b), Chapter 916 (S.B. 1404), Acts of the
- 13 85th Legislature, Regular Session, 2017.
- 14 SECTION 6.02. EVALUATION OF STATE PROCUREMENT SYSTEM
- 15 Section 2151.0042, Government Code, is repealed.
- 16 SECTION 6.03. STATE USE PROGRAM, TEXAS COMPTROLLER OF
- 17 PUBLIC ACCOUNTS. Section 122.0012(a), Human Resources Code, is

- 21 ARTICLE 7. SUNSET REVIEW PROCESS
- 22 SECTION 7.01. DEFINITIONS. Section 325.002(1), Government
- 23 Code, is amended to read as follows:
- 24 (1) "State agency" means an <u>entity</u> [<del>agency</del>] expressly
- 25 made subject to this chapter.
- SECTION 7.02. SUNSET ADVISORY COMMISSION. Section 325.003,
- 27 Government Code, is amended by amending Subsection (a) and adding

- 1 Subsection (a-1) to read as follows:
- 2 (a) The Sunset Advisory Commission is a legislative agency
- 3 that consists of five members of the senate and one public member
- 4 appointed by the lieutenant governor and five members of the house
- 5 of representatives and one public member appointed by the speaker
- 6 of the house. The lieutenant governor and the speaker of the house
- 7 may serve as one of the legislative appointees.
- 8 (a-1) A public member acts on behalf of the legislature when
- 9 participating on the commission in furtherance of the legislature's
- 10 duty to provide oversight of executive branch agencies'
- 11 implementation of legislative priorities.
- 12 SECTION 7.03. RECOMMENDATIONS. Section 325.0126,
- 13 Government Code, is amended to read as follows:
- 14 Sec. 325.0126. MONITORING OF RECOMMENDATIONS. During each
- 15 legislative session, the staff of the commission shall:
- 16 (1) monitor legislation affecting agencies that have
- 17 undergone sunset review immediately before the legislative
- 18 session;
- 19 (2) notify [and shall periodically report to] the
- 20 members of the commission about any amendment to the legislation
- 21 prepared under Section 325.012(c) that modifies the commission's
- 22 [on proposed changes which would modify prior] recommendations for
- 23 <u>a state agency; and</u>
- 24 (3) provide legislative services to support the
- 25 passage of the legislation prepared under Section 325.012(c) [of
- 26 the commission].

1 ARTICLE 8. EFFECTIVE DATE

SECTION 8.01. EFFECTIVE DATE. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for

6 immediate effect, this Act takes effect September 1, 2019.
