A BILL TO BE ENTITLED AN ACT

1-17 1-18 relating to the distribution to the Texas Racing Commission of certain money deducted from simulcast pari-mutuel pools. 1-19

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 2028.202(a), Occupations Code, is amended to read as follows: 1-21

1-22 1-23 A racetrack association shall distribute from the total (a) amount deducted as provided by Sections 2028.101 and 2028.152 from 1-24 each simulcast pari-mutuel pool and each simulcast cross-species 1-25 pari-mutuel pool the following shares:

1-26 (1) an amount equal to one percent of each simulcast pari-mutuel pool to the commission for the administration of this subtitle [as the amount set aside for this state]; 1**-**27 1**-**28

(2) an amount equal to 1.25 percent of each simulcast 1-29 cross-species pari-mutuel pool to the commission for administration of this subtitle [as the amount set aside for 1-30 for the 1-31 this 1-32 state];

1-33 for a horse racetrack association, an amount equal (3) 1-34 to one percent of a multiple two wagering pool or multiple three 1-35 wagering pool as the amount set aside for the Texas-bred program to 1-36 be used as provided by Section 2028.103;

(4) for a greyhound racetrack association, an amount equal to one percent of a multiple two wagering pool or a multiple 1-37 1-38 three wagering pool as the amount set aside for the Texas-bred 1-39 program for greyhound races, to be distributed and used in 1-40 1-41 accordance with commission rules adopted to promote greyhound 1-42 breeding in this state; and

1-43 (5) the remainder as the amount set aside for purses, 1-44 expenses, the sending track, and the receiving location under a 1-45 contract approved by the commission between the sending track and the receiving location. 1-46

1-47 SECTION 2. (a) The change in law made by this Act applies to the deduction from a pari-mutuel pool for a race conducted by a 1-48 1-49 racetrack association on or after the effective date of this Act.

1-50 As soon as practicable after the effective date of this (b) Act, the Texas Racing Commission shall revise existing rules or 1-51 adopt new rules as necessary to comply with Section 2028.202(a), 1-52 1-53 Occupations Code, as amended by this Act. 1-54

SECTION 3. This Act takes effect September 1, 2019.
