A BILL TO BE ENTITLED AN ACT

1-19 relating to authorizing the sale or transfer of the G. J. Sutton 1-20 Building Complex in San Antonio.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-21 SECTION 1. (a) As soon as practical, subject to Subsection (b) of this section, the General Land Office shall offer for sale or transfer on behalf of the state the real property known as the 1-22 1-23 1-24 1-25 G. J. Sutton Building Complex in San Antonio and described by Subsection (c) of this section. The General Land Office shall 1-26 1-27 1-28 conduct the sale or transfer under this Act using the procedures under Section 31.158, Natural Resources Code.

The General Land Office may not sell or transfer the 1-29 (b) 1-30 real property described by Subsection (c) of this section unless 1-31 the conveyance includes covenants, conditions, or restrictions 1-32 that require:
