## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the filing of a degree plan by students at public
- 3 institutions of higher education.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 51.9685(a)(2), Education Code, is
- 6 amended to read as follows:
- 7 (2) "Institution of higher education" <u>has</u> [and "public
- 8 junior college" have] the meaning [meanings] assigned by Section
- 9 61.003.
- 10 SECTION 2. Sections 51.9685(b), (c), and (g), Education
- 11 Code, are amended to read as follows:
- 12 (b) Except as otherwise provided by Subsection (c), each
- 13 student enrolled at an institution of higher education in an
- 14 associate or bachelor's degree program or a course for joint high
- 15 school and junior college credit under Section 130.008 [at an
- 16 institution of higher education] shall file a degree plan with the
- 17 institution not later than the <u>first day of the [end of the second</u>]
- 18 regular semester or term immediately following the semester or term
- 19 in which the student earned a cumulative total of 30 [45] or more
- 20 semester credit hours for coursework successfully completed by the
- 21 student, including transfer courses, international baccalaureate
- 22 courses, dual credit courses, and any other course for which the
- 23 institution the student attends has awarded the student college
- 24 course credit, including course credit awarded by examination.

- (c) A student to whom this section applies who begins the student's first semester or term at an institution of higher education with 30 [45] or more semester credit hours of course credit for courses described by Subsection (b) shall file a degree plan with the institution not later than the 12th class day [end] of that [the student's second regular] semester or term [at the institution].
- 8 (g) The Texas Higher Education Coordinating Board, in 9 consultation with institutions of higher education, <u>shall</u> [may] 10 adopt rules as necessary for the administration of this section, 11 including rules to ensure compliance with this section.
- 12 SECTION 3. Section 130.0104(c), Education Code, is amended 13 to read as follows:
- 14 In complying with the requirements regarding the filing 15 of a degree plan under [Notwithstanding] Section 51.9685, [before the beginning of the regular semester or term immediately following 16 17 the semester or term in which] a student enrolled [successfully completes a cumulative total of 30 or more semester credit hours for 18 coursework] in a multidisciplinary studies associate degree 19 program established under this section [, the student] must meet 20 with an academic advisor to complete a degree plan [, as defined by 21 22 Section 51.9685(a)(1), that:
- 23 (1) accounts for all remaining credit hours required 24 for the completion of the degree program; and
- 25 (2) emphasizes:
- 26 (A) the student's transition to a particular 27 four-year college or university that the student chooses; and

- 1 (B) preparations for the student's intended
- 2 field of study or major at the four-year college or university.
- 3 SECTION 4. Section 51.9685(c-1), Education Code, is
- 4 repealed.
- 5 SECTION 5. This Act applies beginning with the 2019-2020
- 6 academic year.
- 7 SECTION 6. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2019.
