Sec. 8050.0202. TEMPORARY DIRECTORS. (a) On or after the effective date of the Act enacting this chapter, the owner or owners of a majority of the assessed value of the real property in the district may submit a petition to the commission requesting that the commission appoint as temporary directors the five persons named in the petition. The commission shall appoint as temporary directors the five persons named in the petition.

(b)

Temporary directors serve until the earlier of:
(1) the date permanent directors are elected under Section 8050.0103; or

(2) the fourth anniversary of the effective date of the Act enacting this chapter.

(c) If permanent directors have not been elected under Section 8050.0103 and the terms of the temporary directors have expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that expire on the earlier of:

(1) the date permanent directors are elected under Section 8050.0103; or

(2) the fourth anniversary of the date of the appointment or reappointment.

If Subsection (c) applies, the owner or owners of majority of the assessed value of the real property in the district may submit a petition to the commission requesting that the commission appoint as successor temporary directors the five persons named in the petition. The commission shall appoint as successor temporary directors the five persons named in petition.

SUBCHAPTER C. POWERS AND DUTIES

Sec. 8050.0301. GENERAL POWERS AND DUTIES. The district has the powers and duties necessary to accomplish the purposes for

which the district is created.

Sec. 8050.0302. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59,

Article XVI, Texas Constitution.

Sec. 8050.0303. AUTHORITY FOR ROAD PROJECTS. Sec. 8050.0303. AUTHORITY FUR RUAD PROJECTS. Officer Section.

the road project is located.
(c) If the state will maintain and operate the road, Texas Transportation Commission must approve the plans and specifications of the road project.

Sec. 8050.0305. COMPLIANCE WITH MUNICIPAL CONSENT

ORDINANCE OR RESOLUTION. The district shall comply with all applicable requirements of any ordinance or resolution that is adopted under Section 54.016 or 54.0165, Water Code, and that 3-1 3-2 3-3 3-4 consents to the creation of the district or to the inclusion of land in the district. 3-5

Sec. 8050.0306. DIVISION OF DISTRICT. (a) The district may be divided into two or more new districts only if the district:

has never issued any bonds; and is not imposing ad valorem taxes. (2)

- (b) This chapter applies to any new district created by the division of the district, and a new district has all the powers and duties of the district.

Section 49.108, Water Code, the district may impose a tax other than an operation and maintenance tax and use the revenue derived from the tax to make payments under a contract after the provisions of the contract have been approved by a majority of the district voters voting at an election held for that purpose.

SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

Sec. 8050.0501. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS. The district may issue bonds or other obligations payable wholly or partly from ad valorem taxes, impact fees, revenue, contract payments, grants, or other district money, or any combination of those sources, to pay for any authorized district purpose.

Sec. 8050.0503. BONDS FOR ROAD PROJECTS. At the time of issuance, the total principal amount of bonds or other obligations issued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the district.
