RESOLUTION

1 WHEREAS, Merily H. Keller has distinguished herself as a 2 steadfast advocate for mental health in the State of Texas throughout her many years of service as a co-coordinator and 3 founding board member of the Texas Suicide Prevention Council; and 4 WHEREAS, Ms. Keller's tireless efforts have helped TSPC grow 5 to include more than 70 local coalitions, which are united in their 6 7 commitment to reducing incidents of suicide in Texas; a statewide 8 master trainer for the organization, she developed an 9 evidence-based suicide prevention program called "ASK," along with a number of apps, videos, and other instructional materials, and 10 11 she authored and edited "Coming Together to Care: A Suicide 12 Prevention and Postvention Toolkit for Texas Communities"; she also serves on the Texas Health and Human Services Commission's ad hoc 13 14 Postvention Task Force, which assists schools and communities in the aftermath of youth suicide attempts and deaths; along the way, 15 16 she has assisted in the passage of legislation allowing Texas communities to share timely data on deaths by suicide and requiring 17 suicide prevention plans to be implemented at all Texas school 18 19 districts; and 20 WHEREAS, Ms. Keller has long been a leader and a catalyst for change, having been part of the steering team that wrote the Texas 21 State Plan for Suicide Prevention in 2002; in addition, she was 22 23 among the founders of the Central Texas Chapter of the American Foundation for Suicide Prevention and the Austin/Travis County 2.4

- 8 communications and education outreach; today, she regularly speaks

- 10 prevention and postvention, as well as delivers presentations and
- 11 attends panels for state and regional suicide prevention summits;
- 12 she is the recipient of numerous accolades for her work, including a
- 13 2015 Lifetime Achievement Award from Women Communicators of Austin;

- 16 in a multitude of other organizations, Merily Keller has done
- 17 tremendous work to make suicide prevention a public health priority
