 1-20 AN ACT

1-21 relating to the number of school marshals that may be appointed to
 1-22 serve on a public school campus or at a private school.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 37.0811(a), Education Code, is amended
 1-25 to read as follows:

1-26 (a) The board of trustees of a school district or the
 1-27 governing body of an open-enrollment charter school may appoint one
 1-28 or more school marshals for each campus [~~not more than the greater~~
 1-29 ~~of:~~

1-30 [~~(1) one school marshal per 200 students in average~~
 1-31 ~~daily attendance per campus; or~~

1-32 [~~(2) for each campus, one school marshal per building of~~
 1-33 ~~the campus at which students regularly receive classroom~~
 1-34 ~~instruction].~~

1-35 SECTION 2. Section 37.0813(a), Education Code, is amended
 1-36 to read as follows:

1-37 (a) The governing body of a private school may appoint one
 1-38 or more school marshals [~~not more than the greater of:~~

1-39 [~~(1) one school marshal per 200 students enrolled in~~
 1-40 ~~the school; or~~

1-41 [~~(2) one school marshal per building of the school at~~
 1-42 ~~which students regularly receive classroom instruction].~~

1-43 SECTION 3. This Act applies beginning with the 2019-2020
 1-44 school year.

1-45 SECTION 4. This Act takes effect immediately if it receives
 1-46 a vote of two-thirds of all the members elected to each house, as
 1-47 provided by Section 39, Article III, Texas Constitution. If this
 1-48 Act does not receive the vote necessary for immediate effect, this
 1-49 Act takes effect September 1, 2019.
