SECTION 3. (a) If this Act receives the votes necessary for immediate effect, the lieutenant governor and the speaker of the house of representatives shall make appointments to the Joint Oversight Committee on Government Facilities not later than July 1, 2019.

(b) If this Act does not receive the votes necessary for immediate effect, the lieutenant governor and the speaker of the house of representatives shall make appointments to the Joint Oversight Committee on Government Facilities not later than September 15, 2019.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.
