SECTION 2. Subchapter B, Chapter 21, Property Code,

Sec. 21.01101. SURVEY PERMISSION FORM. If an entity with eminent domain authority provides a form to an owner of real property requesting the owner's permission to enter the property to examine the property or conduct a survey of the property in connection with the potential acquisition of the property for a

the form must conspicuously state that:
(1) the owner has a right to refuse to grant permission to the entity to enter the property and conduct the examination or survey;

(2) the entity has a right to sue for a court order authorizing the entity to enter the property and conduct the examination or survey if the owner refuses to grant the permission;

(3) the owner has a right to negotiate the terms of the

examination or survey of the property; and

(4) the entity has the responsibility for any damages

arising from an examination or survey of the property.

SECTION 3. The office of the attorney general shall make the landowner's bill of rights statement required by Section 402.031, Government Code, as amended by this Act, available on the attorney general's Internet website not later than January 1, 2020.
