- 14 Sec. 411.506. INFORMAL COMPLAINT RESOLUTION AND INFORMAL
- 15 PROCEEDINGS. (a) The commission by rule shall establish
- 16 procedures for the informal resolution of complaints filed with the
- 17 department related to a violation of a law or rule governing a
- 18 program or person subject to this subchapter, including procedures
- 19 governing:
- 20 (1) informal disposition of a contested case under
- 21 <u>Section 2001.056; and</u>
- 22 (2) an informal proceeding held in compliance with

- 24 (b) Any settlement agreement arising from the procedures

- Sec. 411.507. LICENSE DENIAL; ADMINISTRATIVE SANCTION. (a)

- 1 This section applies to a person required to obtain a license under
- 2 a program subject to this subchapter.
- 3 (b) The commission may deny an application for, revoke,
- 4 suspend, or refuse to renew a license or may reprimand a license
- 5 holder for a violation of a law or rule governing a program subject
- 6 to this subchapter.
- 7 (c) The commission may place on probation a person whose
- 8 <u>license</u> is suspended. If a license suspension is probated, the
- 9 commission may require the person to:
- 10 (1) report regularly to the department on matters that
- 11 are the basis of the probation;
- 12 (2) limit practice to the areas prescribed by the
- 13 department; or
- 14 (3) continue or renew education until the person
- 15 attains a degree of competency satisfactory to the commission in
- 16 those areas that are the basis for the probation.
- 17 (d) The commission shall develop a penalty schedule for each
- 18 program subject to this subchapter consisting of administrative
- 19 sanctions authorized under Subsections (b) and (c) based on the
- 20 severity and frequency of a violation of a law or rule related to
- 21 the program.
- Sec. 411.508. RIGHT TO NOTICE AND HEARING; ADMINISTRATIVE
- 23 PROCEDURE. (a) For each program subject to this subchapter, a
- 24 person is entitled to notice and a hearing if the commission
- 25 proposes to:
- 26 (1) deny an application for, revoke, suspend, or
- 27 refuse to renew a license;

- 1 (2) reprimand a license holder; or
- 2 (3) place a license holder on probation.
- 3 (b) A proceeding to impose an administrative sanction as
- 4 described by Subsection (a) is a contested case under Chapter 2001.
- 5 (c) Unless otherwise provided by law, judicial review of an
- 6 administrative sanction or penalty imposed by the commission is
- 7 under the substantial evidence rule as provided by Subchapter G,
- 8 Chapter 2001.
- 9 Sec. 411.509. CEASE AND DESIST ORDER. The department may
- 10 <u>issue</u> a cease and desist order if the department determines that the
- 11 action is necessary to prevent a violation of a law or rule
- 12 governing a program or person subject to this subchapter.
- Sec. 411.510. INJUNCTIVE RELIEF. (a) On request of the
- 14 department, the attorney general shall institute an action for
- 15 injunctive relief to restrain a person in violation of or
- 16 threatening to violate a law or rule governing a program or person
- 17 subject to this subchapter.
- 18 (b) An action filed under this section shall be filed in a
- 19 district court in:
- 20 (1) Travis County; or
- 21 (2) the county in which the violation allegedly
- 22 occurred or is threatened to occur.
- 23 <u>(c) The attorney general may recover reasonable expenses</u>
- 24 incurred in obtaining injunctive relief under this section,
- 25 including court costs, attorney's fees, investigative costs,
- 26 witness fees, and deposition expenses.
- Sec. 411.511. STAGGERED RENEWAL; PRORATION OF LICENSE FEE.

- 1 (a) The commission by rule may adopt a system under which licenses
- 2 expire on various dates during the year.
- 3 (b) A license issued under a program governed by this
- 4 subchapter may not expire later than the second anniversary of the
- 5 date the license is issued.
- 6 (c) For the year in which the expiration date of a license is
- 7 changed, the department shall prorate license fees on a monthly
- 8 basis so that each license holder pays only that portion of the
- 9 license fee that is allocable to the number of months during which
- 10 the license is valid. On renewal of the license on the new
- 11 <u>expiration date</u>, the total license renewal fee is payable.
- 12 Sec. 411.512. ANNUAL REGULATORY REPORT. (a) The
- 13 department shall annually make available on the department's
- 14 Internet website a report of regulatory statistics for the
- 15 preceding state fiscal year for each program subject to this
- 16 <u>subchapter and aggregate information on all the programs.</u>
- 17 <u>(b) The report must include, as applicable, information</u>
- 18 regarding:
- 19 (1) the number of licenses issued under the program;
- 20 (2) the number and types of complaints received and
- 21 resolved by the department;
- 22 (3) the number of investigations conducted by the
- 23 department; and
- 24 (4) the number and types of disciplinary actions taken
- 25 by the department.
- SUBCHAPTER R. ADMINISTRATIVE PENALTY
- Sec. 411.521. DEFINITION. In this subchapter, "license"

- 1 has the meaning assigned by Section 411.501.
- Sec. 411.522. APPLICABILITY. This subchapter applies to a
- 3 program, and persons regulated under the program, to which Section
- 4 411.502 applies.
- 5 Sec. 411.523. IMPOSITION OF PENALTY. The commission may
- 6 impose an administrative penalty against a person who violates:
- 7 (1) a law establishing a program subject to this
- 8 subchapter; or
- 9 (2) a rule adopted or order issued by the commission
- 10 under a law described by Subdivision (1).
- Sec. 411.524. AMOUNT OF PENALTY. (a) If the relevant law
- 12 establishing a program subject to this subchapter does not state
- 13 the maximum amount of an administrative penalty under that law, the
- 14 amount of the penalty shall be assessed by the commission in an
- 15 amount not to exceed \$5,000 per day for each violation. Each day a
- 16 <u>violation continues or occurs is a separate violation for purposes</u>
- 17 of imposing a penalty.
- 18 (b) The amount of the penalty shall be based on:
- 19 (1) the seriousness of the violation;
- 20 (2) the respondent's history of previous violations;
- 21 (3) the amount necessary to deter a future violation;
- 22 (4) efforts made by the respondent to correct the
- 23 <u>violation; and</u>
- 24 (5) any other matter that justice may require.
- 25 (c) The commission shall establish a written enforcement
- 26 plan that provides notice to license holders of the specific ranges
- 27 of penalties that apply to specific alleged violations and the

- 1 criteria by which the department determines the amount of a
- 2 proposed administrative penalty.
- 3 Sec. 411.525. IMPOSITION OF SANCTION. A proceeding under
- 4 this subchapter imposing an administrative penalty may be combined
- 5 with a proceeding to impose an administrative sanction. If a
- 6 sanction is imposed in a proceeding under this subchapter, the
- 7 requirements of this subchapter apply to the imposition of the
- 8 sanction.
- 9 Sec. 411.526. NOTICE OF VIOLATION AND PENALTY. If, after
- 10 investigation of a possible violation and the facts surrounding the
- 11 possible violation, the department determines that a violation
- 12 occurred, the department shall issue to the respondent a notice of
- 13 alleged violation stating:
- 14 (1) a brief summary of the alleged violation;
- 15 (2) the amount of the recommended administrative
- 16 penalty; and
- 17 (3) that the respondent has the right to a hearing to
- 18 contest the alleged violation, the amount of the penalty, or both.
- 19 Sec. 411.527. PENALTY TO BE PAID OR HEARING REQUESTED. (a)
- 20 Not later than the 20th day after the date the respondent receives
- 21 the notice, the respondent may:
- (1) accept the department's determination and
- 23 <u>recommended administrative penalty; or</u>
- (2) make a written request for a hearing on that
- 25 determination.
- 26 (b) If the respondent accepts the department's
- 27 determination, the commission by order may approve the

- 1 determination and require the person to pay the recommended
- 2 penalty.
- 3 Sec. 411.528. HEARING ON RECOMMENDATIONS. (a) If the
- 4 respondent requests a hearing, the hearing shall be conducted by
- 5 the department or the State Office of Administrative Hearings.
- 6 (b) The State Office of Administrative Hearings shall
- 7 consider the department's applicable substantive rules and
- 8 policies when conducting a hearing under this subchapter.
- 9 (c) A department hearing officer or an administrative law
- 10 judge at the State Office of Administrative Hearings, as
- 11 applicable, shall:
- 12 (1) make findings of fact and conclusions of law; and
- 13 (2) promptly issue to the commission a proposal for
- 14 decision as to the occurrence of the violation and the amount of any
- 15 proposed administrative penalty.
- Sec. 411.529. DECISION BY COMMISSION. (a) Based on the
- 17 findings of fact, conclusions of law, and proposal for decision,
- 18 the commission by order may determine that:
- 19 (1) a violation occurred and impose an administrative
- 20 penalty; or
- 21 (2) a violation did not occur.
- 22 (b) The department shall give notice of the order to the
- 23 <u>respondent.</u>
- (c) The order under this section must include:
- 25 (1) separate statements of the findings of fact and
- 26 conclusions of law;
- 27 (2) the amount of any penalty imposed;

(3) a statement of the right of the respondent to 1 2 judicial review of the order; and 3 (4) any other information required by law. 4 Sec. 411.530. OPTIONS FOLLOWING DECISION: PAY OR APPEAL. 5 (a) Not later than the 30th day after the date the commission's order becomes final, the respondent shall: 6 7 (1) pay the penalty; or 8 (2) file a petition for judicial review contesting the order and: 9 10 (A) forward the penalty to the department for deposit in an escrow account; or 11 12 (B) give the department a supersedeas bond in a 13 form approved by the department that: 14 (i) is for the amount of the penalty; and 15 (ii) is effective until judicial review of 16 the decision is final. 17 (b) A respondent who is financially unable to comply with Subsection (a)(2) is entitled to judicial review if the respondent 18 19 files with the court, as part of the respondent's petition for judicial review, a sworn statement that the respondent is unable to 20 meet the requirements of Subsection (a)(2). 21 Sec. 411.531. - 25 (2) "Program" means the motorcycle operator training
- 26 and safety program established under Chapter 662, Transportation
- 27 Code, as that chapter existed before the effective date of this Act.

- (b) As soon as practicable after the effective date of this article and not later than August 31, 2019, the department shall dispose of motorcycles and other equipment related to the program that the department possesses or has leased to entities offering training under the program. The plan must conform with the requirements of Subsection (c) of this section.
- 7 (c) The department shall dispose of the motorcycles and 8 other equipment related to the program in the following manner:
- 9 (1) the department shall provide to any entity to whom 10 the department leased a motorcycle or other equipment related to 11 the program a reasonable period determined by the department to 12 purchase from the department or return the motorcycle or other 13 equipment;
- 14 (2) after the expiration of the period described by 15 Subdivision (1) of this subsection, the department shall:
- (A) determine the need of the Texas Department of
 Licensing and Regulation, the Texas A&M Transportation Institute,

- 27 (3) after the determination and any transfer under
