SECTION 2. Section 42.042, Human Resources Code, is amended by adding Subsection (m-1) to read as follows: 2-17

(m-1) Not later than January 1, 2021, 2-18 the executive commissioner shall review the data collected under Section 42.0412 2-19 2-20 2-21 and prepare and submit to the legislature a report that includes recommendations regarding modifications to the minimum standards 2-22 by age group to enhance child safety. This subsection expires September 1, 2023. 2-23

SECTION 3. Notwithstanding Section 42.0412(d), 2-24 Human Resources Code, as added by this Act, the Health and Human Services Commission is not required to comply with that subsection until 2**-**25 2**-**26 2-27 January 31, 2020.

SECTION 4. 2-28 This Act takes effect immediately if it receives 2-29 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this 2-30 2-31 2-32 Act takes effect September 1, 2019.
