## A BILL TO BE ENTITLED

	AN ACT

- 2 relating to requirements for new or increased municipal fees.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Chapter 102, Local Government Code, is amended
- 5 by adding Section 102.0001 to read as follows:
- 6 Sec. 102.0001. DEFINITION. In this chapter, "fee" has the
- 7 meaning assigned by Section 109.001.
- 8 SECTION 2. Section 102.005, Local Government Code, is
- 9 amended by adding Subsection (b-1) to read as follows:
- 10 (b-1) A proposed budget that includes estimated revenue
- 11 from a new fee or the increase of an existing fee must contain a
- 12 cover page with the following statement in 18-point or larger type:
- 13 "This budget includes estimated revenue from the following new or
- 14 increased fees: (include a description of each new or increased
- 15 fee, the dollar amount of each new fee, and the dollar amount of and
- 16 percentage of increase of each increased fee)."
- SECTION 3. Section 102.006(c), Local Government Code, is
- 18 amended to read as follows:
- 19 (c) The governing body shall provide for public notice of
- 20 the date, time, and location of the hearing. The notice must
- 21 include, in type of a size at least equal to the type used for other
- 22 items in the notice, any statement required to be included in the
- 23 proposed budget under Section 102.005(b) or (b-1).
- SECTION 4. Section 102.0065(d), Local Government Code, is

- 1 amended to read as follows:
- 2 (d) Notice under this section must include, in type of a
- 3 size at least equal to the type used for other items in the notice,
- 4 any statement required to be included in the proposed budget under
- 5 Section 102.005(b) or (b-1).
- 6 SECTION 5. Section 102.007, Local Government Code, is
- 7 amended by adding Subsection (c-1) and amending Subsection (d) to
- 8 read as follows:
- 9 (c-1) Adoption of a budget that includes estimated revenue
- 10 from a new fee or the increase of an existing fee requires a
- 11 separate vote of the governing body to ratify the use of that
- 12 revenue. A vote under this subsection is in addition to and
- 13 separate from the vote to adopt the budget or a vote to adopt or
- 14 increase the fee.
- 15 (d) An adopted budget must contain a cover page that
- 16 includes:
- 17 (1) one of the following statements in 18-point or
- 18 larger type that accurately describes the adopted budget:
- 19 (A) "This budget will raise more revenue from
- 20 property taxes than last year's budget by an amount of (insert total
- 21 dollar amount of increase), which is a (insert percentage increase)
- 22 percent increase from last year's budget. The property tax revenue
- 23 to be raised from new property added to the tax roll this year is
- 24 (insert amount computed by multiplying the proposed tax rate by the
- 25 value of new property added to the roll).";
- 26 (B) "This budget will raise less revenue from
- 27 property taxes than last year's budget by an amount of (insert total

- 1 dollar amount of decrease), which is a (insert percentage decrease)
- 2 percent decrease from last year's budget. The property tax revenue
- 3 to be raised from new property added to the tax roll this year is
- 4 (insert amount computed by multiplying the proposed tax rate by the
- 5 value of new property added to the roll)."; or
- 6 (C) "This budget will raise the same amount of
- 7 revenue from property taxes as last year's budget. The property
- 8 tax revenue to be raised from new property added to the tax roll
- 9 this year is (insert amount computed by multiplying the proposed
- 10 tax rate by the value of new property added to the roll).";
- 11 (2) <u>if applicable</u>, the following statement in 18-point
- 12 or larger type: "This budget includes estimated revenue from the
- 13 following new or increased fees: (include a description of each new
- 14 or increased fee, the dollar amount of each new fee, and the dollar
- amount of and percentage of increase of each increased fee).";
- 16 (3) the record vote of each member of the governing
- 17 body by name voting on the adoption of the budget;
- (4)  $[\frac{3}{3}]$  the municipal property tax rates for the
- 19 preceding fiscal year, and each municipal property tax rate that
- 20 has been adopted or calculated for the current fiscal year,
- 21 including:
- 22 (A) the property tax rate;
- 23 (B) the effective tax rate;
- (C) the effective maintenance and operations tax
- 25 rate;
- 26 (D) the rollback tax rate; and
- 27 (E) the debt rate; and

- 1 (5) (4) the total amount of municipal debt
- 2 obligations.
- 3 SECTION 6. Section 102.008, Local Government Code, is
- 4 amended to read as follows:
- 5 Sec. 102.008. APPROVED BUDGET FILED WITH MUNICIPAL
- 6 CLERK: POSTING ON INTERNET. (a) On final approval of the budget
- 7 by the governing body of the municipality, the governing body
- 8 shall:
- 9 (1) file the budget with the municipal clerk; and
- 10 (2) if the municipality maintains an Internet website,
- 11 take action to ensure that:
- 12 (A) a copy of the budget, including the cover
- 13 page, is posted on the website; and
- 14 (B) the record vote described by Section
- 15  $102.007(d)(3) [\frac{102.007(d)(2)}{2}]$  is posted on the website at least
- 16 until the first anniversary of the date the budget is adopted.
- 17 (b) The governing body shall take action to ensure that the
- 18 cover page of the budget is amended to include the property tax
- 19 rates required by Section  $102.007(d)(4) [\frac{102.007(d)(3)}{3}]$  for the
- 20 current fiscal year if the rates are not included on the cover page
- 21 when the budget is filed with the municipal clerk. The governing
- 22 body shall file an amended cover page with the municipal clerk and
- 23 take action to ensure that the amended cover page is posted on the
- 24 municipality's website.
- 25 SECTION 7. Subtitle A, Title 4, Local Government Code, is
- 26 amended by adding Chapter 109 to read as follows:

- 1 CHAPTER 109. NOTIFICATION OF NEW OR INCREASED MUNICIPAL FEES
- 2 Sec. 109.001. DEFINITION. In this chapter, "fee" means any
- 3 fee, charge, assessment, or similar payment required by a
- 4 municipality for a privilege, service, authorization, permit,
- 5 <u>license</u>, registration, certification, filing, or other municipal
- 6 action or approval.
- 7 Sec. 109.002. E-MAIL NOTIFICATION SERVICE IN CERTAIN
- 8 MUNICIPALITIES. (a) This section does not apply to a municipality
- 9 located primarily in a county with a population of less than 30,000.
- 10 (b) Except as provided by Subsection (c), each municipality
- 11 shall establish and maintain an e-mail notification service to
- 12 which any person may electronically subscribe to receive
- 13 information regarding new or increased municipal fees.
- 14 (c) A municipality that does not maintain an e-mail
- 15 notification service for any purpose on January 1, 2019, may post
- 16 the notifications described by Subsection (d)(1) on the Internet
- 17 website of the municipality that are accessible from a prominently
- 18 displayed link on the home page of that website instead of
- 19 establishing an e-mail notification service as prescribed by this
- 20 <u>section.</u>
- 21 <u>(d) The e-mail notification service must:</u>
- 22 (1) allow a subscriber to request notification of
- 23 each:
- (A) new fee proposed to be adopted by the
- 25 municipality;
- 26 (B) existing fee proposed to be increased by the
- 27 municipality;

- 1 (C) proposed budget of the municipality that
- 2 includes use of revenue from a fee described by Paragraph (A) or
- 3 (B);
- 4 (D) adopted budget of the municipality that
- 5 includes use of revenue from a fee described by Paragraph (A) or
- 6 (B); or
- 7 (E) public hearing scheduled to be held at which
- 8 <u>a fee or budget described by Paragraphs (A)-(D) is scheduled to be</u>
- 9 discussed;
- 10 (2) include a link in the notification to any web page
- 11 maintained by the municipality on which the fee or budget may be
- 12 viewed; and
- 13 (3) notify the subscriber by e-mail not later than the
- 14 day:
- 15 (A) the municipality provides public notice of a
- 16 public hearing at which a proposed new or increased fee or a
- 17 proposed budget is scheduled to be discussed, for notification of a
- 18 public hearing for a proposed fee or budget;
- 19 (B) the budget officer files a proposed budget
- 20 with the municipal clerk as required by Section 102.005, for
- 21 notification of a proposed budget; or
- (C) the governing body files an adopted budget
- 23 with the municipal clerk as required by Section 102.008, for
- 24 notification of an adopted budget.
- 25 SECTION 8. Sections 102.005, 102.006, 102.0065, 102.007,
- 26 and 102.008, Local Government Code, as amended by this Act, apply
- 27 only to a proposed or adopted budget for a fiscal year beginning on

- 1 or after January 1, 2020.
- 2 SECTION 9. This Act takes effect September 1, 2019.
