BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle D, Title 2, Health and Safety Code, is amended by adding Chapter 99 to read as follows:

CHAPTER 99. STATE PLAN FOR ALZHEIMER'S DISEASE AND RELATED

DISORDERS

Sec. 99.001. DEVELOPMENT AND IMPLEMENTATION OF STATE PLAN. (a) The department, using existing resources and programs to the extent possible, shall develop and implement a state plan for education on and treatment of Alzheimer's disease and related disorders.

(b) The state plan must include best practices and for: strategies

improving early detection of, reducing disease (1) onset risks for, and improving treatment of Alzheimer's disease and related disorders for specific demographic groups;

educating health care professionals, caregivers, to increase awareness of Alzheimer's disease and (2) public to and the related disorders;

(3) providing caregiver support;

(4) advancing basic science and applied

related to Alzheimer's disease and related disorders; and

(5) collecting and evaluating information on eff
to prevent and treat Alzheimer's disease and related disorders.

Sec. 99.002. COMMENTS FROM INTERESTED PARTIES. (a) developing the state plan under Section 99.001, the department shall seek comments from interested parties, including:

members of the public with, or who care for persons 's disease or related disorders; with, Alzheimer

(2) each state agency that provides services to persons with Alzheimer's disease or related disorders;

(3) any advisory body that addresses issues related to disease or related disorders;

(4) public advocates concerned with issues related to Alzheimer's disease or related disorders;

(5) health care providers who provide services to

persons with Alzheimer's disease or related disorders; and
(6) researchers of issues affecting persons with Alzheimer's disease or related disorders.

(b) On request of the department, 1-59 the commission shall 1-60 provide information and comments related to services provided to persons with Alzheimer's disease or related disorders. 1-61
