A BILL TO BE ENTITLED

AN ACT

1-21 relating to the eligibility of certain exhibitions and festivals to
1-22 receive funding through the Major Events Reimbursement Program.
1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Sections 5A(a)(4) and (5), Chapter 1507 (S.B. 1-25 456), Acts of the 76th Legislature, Regular Session, 1999 (Article 1-26 5190.14, Vernon's Texas Civil Statutes), are amended to read as 1-27 follows:
