1-15 A BILL TO BE ENTITLED
1-16 AN ACT

1-17 relating to the photograph on certain forms of state-issued
1-18 identification.

1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 1702.232(c), Occupations Code, is
1-21 amended to read as follows:

1-22 (c) The pocket card must:

1-23 (1) state the name of the registrant;

1-24 (2) contain a ~~color~~ photograph, affixed to the
1-25 pocket card by the board at the time the card is issued, and the
1-26 signature of the registrant;

1-27 (3) state the date the card was issued and the card's
1-28 expiration date; and

1-29 (4) state each endorsement held by the registrant and
1-30 the date the endorsement expires.

1-31 SECTION 2. Section 411.179(a), Government Code, is amended
1-32 to read as follows:

1-33 (a) The department by rule shall adopt the form of the
1-34 license. A license must include:

1-35 (1) a number assigned to the license holder by the
1-36 department;

1-37 (2) a statement of the period for which the license is
1-38 effective;

1-39 (3) a ~~color~~ photograph of the license holder;

1-40 (4) the license holder's full name, date of birth, hair
1-41 and eye color, height, weight, and signature;

1-42 (5) the license holder's residence address or, as
1-43 provided by Subsection (d), the street address of the courthouse in
1-44 which the license holder or license holder's spouse serves as a
1-45 federal judge or the license holder serves as a state judge;

1-46 (6) the number of a driver's license or an
1-47 identification certificate issued to the license holder by the
1-48 department; and

1-49 (7) the designation "VETERAN" if required under
1-50 Subsection (e).

1-51 SECTION 3. The changes in law made by this Act apply only to
1-52 a pocket card or license issued or renewed on or after the effective
1-53 date of this Act. A pocket card or license issued or renewed before
1-54 the effective date of this Act is governed by the law in effect when
1-55 the pocket card or license was issued, and the former law is
1-56 continued in effect for that purpose.

1-57 SECTION 4. This Act takes effect September 1, 2019.
