1-20 A BILL TO BE ENTITLED
 1-21 AN ACT

1-22 relating to the designation of portions of the state highway system
 1-23 as memorial highways for certain deceased peace officers.

1-24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-25 SECTION 1. Subchapter B, Chapter 225, Transportation Code,
 1-26 is amended by adding Sections 225.190, 225.191, 225.192, 225.193,
 1-27 225.194, 225.195, 225.196, 225.197, 225.198, 225.199, and 225.200
 1-28 to read as follows:

1-29 Sec. 225.190. TROOPER CHAD M. WALKER MEMORIAL HIGHWAY. (a)
 1-30 The portion of State Highway 164 in Limestone County between its
 1-31 intersection with Farm-to-Market Road 1953 and its intersection
 1-32 with County Road 789 is designated as the Trooper Chad M. Walker
 1-33 Memorial Highway. The designation is in addition to any other
 1-34 designation.

1-35 (b) Subject to Section 225.021(c), the department shall:
 1-36 (1) design and construct markers indicating the
 1-37 designation as the Trooper Chad M. Walker Memorial Highway and any
 1-38 other appropriate information; and

1-39 (2) erect a marker at each end of the highway and at
 1-40 appropriate intermediate sites along the highway.

1-41 Sec. 225.191. TROOPER MOISES SANCHEZ MEMORIAL HIGHWAY. (a)
 1-42 The portion of Interstate Highway 69C in Hidalgo County between its
 1-43 intersection with Farm-to-Market Road 1925 and its intersection
 1-44 with Trenton Road is designated as the Trooper Moises Sanchez
 1-45 Memorial Highway. The designation is in addition to any other
 1-46 designation.

1-47 (b) Subject to Section 225.021(c), the department shall:
 1-48 (1) design and construct markers indicating the
 1-49 designation as the Trooper Moises Sanchez Memorial Highway and any
 1-50 other appropriate information; and

1-51 (2) erect a marker at each end of the highway and at
 1-52 appropriate intermediate sites along the highway.

1-53 Sec. 225.192. TROOPER TROY HOGUE MEMORIAL HIGHWAY. (a) The
 1-54 portion of Interstate Highway 20 in Howard County between mile
 1-55 marker 173 and mile marker 190 is designated as the Trooper Troy
 1-56 Hogue Memorial Highway. The designation is in addition to any other
 1-57 designation.

1-58 (b) Subject to Section 225.021(c), the department shall:
 1-59 (1) design and construct markers indicating the
 1-60 designation as the Trooper Troy Hogue Memorial Highway and any

- 2-2 (2) erect a marker at each end of the highway and at
- 2-3 appropriate intermediate sites along the highway.
- 2-4 Sec. 225.193. CORPORAL WILLIE DALE TAYLOR MEMORIAL HIGHWAY.
- 2-5 (a) The portion of Interstate Highway 10 in Crockett County between
- 2-6 mile marker 363 and mile marker 368 is designated as the Corporal
- 2-7 Willie Dale Taylor Memorial Highway. The designation is in
- 2-8 addition to any other designation.
- 2-9 (b) Subject to Section 225.021(c), the department shall:
- 2-10 (1) design and construct markers indicating the
- 2-11 designation as the Corporal Willie Dale Taylor Memorial Highway and
- 2-12 any other appropriate information; and
- 2-13 (2) erect a marker at each end of the highway and at
- 2-14 appropriate intermediate sites along the highway.
- 2-15 Sec. 225.194. TROOPER JAVIER ARANA JR. MEMORIAL HIGHWAY.
- 2-16 (a) The portion of State Highway Loop 375 in El Paso County between
- 2-17 mile marker 41 and mile marker 44 is designated as the Trooper
- 2-18 Javier Arana Jr. Memorial Highway. The designation is in addition
- 2-19 to any other designation.
- 2-20 (b) Subject to Section 225.021(c), the department shall:
- 2-21 (1) design and construct markers indicating the
- 2-22 designation as the Trooper Javier Arana Jr. Memorial Highway and
- 2-23 any other appropriate information; and
- 2-24 (2) erect a marker at each end of the highway and at
- 2-25 appropriate intermediate sites along the highway.
- 2-26 Sec. 225.195. SERGEANT WILLIAM KUHNLE JR. AND TROOPER RALPH
- 2-27 G. ZERDA MEMORIAL HIGHWAY. (a) The portion of United States
- 2-28 Highway 90 in Bexar County between its intersection with State
- 2-29 Highway 211 and its intersection with Montgomery Road is designated
- 2-30 as the Sergeant William Kuhnle Jr. and Trooper Ralph G. Zerda
- 2-31 Memorial Highway. The designation is in addition to any other
- 2-32 designation.
- 2-33 (b) Subject to Section 225.021(c), the department shall:
- 2-34 (1) design and construct markers indicating the
- 2-35 designation as the Sergeant William Kuhnle Jr. and Trooper Ralph G.
- 2-36 Zerda Memorial Highway and any other appropriate information; and
- 2-37 (2) erect a marker at each end of the highway and at
- 2-38 appropriate intermediate sites along the highway.
- 2-39 Sec. 225.196. TROOPER RICHARD DALE COTTLE MEMORIAL HIGHWAY.
- 2-40 (a) The portion of Interstate Highway 35 in McLennan County between
- 2-41 mile marker 341 and mile marker 351 is designated as the Trooper
- 2-42 Richard Dale Cottle Memorial Highway. The designation is in
- 2-43 addition to any other designation.
- 2-44 (b) Subject to Section 225.021(c), the department shall:
- 2-45 (1) design and construct markers indicating the
- 2-46 designation as the Trooper Richard Dale Cottle Memorial Highway and
- 2-47 any other appropriate information; and
- 2-48 (2) erect a marker at each end of the highway and at
- 2-49 appropriate intermediate sites along the highway.
- 2-50 Sec. 225.197. TROOPER TIMOTHY WADE MCDERMOTT MEMORIAL
- 2-51 HIGHWAY. (a) The portion of United States Highway 80 in Gregg and
- 2-52 Harrison Counties between its intersection with United States
- 2-53 Highway 259 and its intersection with State Loop 281 is designated
- 2-54 as the Trooper Timothy Wade McDermott Memorial Highway. The
- 2-55 designation is in addition to any other designation.
- 2-56 (b) Subject to Section 225.021(c), the department shall:
- 2-57 (1) design and construct markers indicating the
- 2-58 designation as the Trooper Timothy Wade McDermott Memorial Highway
- 2-59 and any other appropriate information; and
- 2-60 (2) erect a marker at each end of the highway and at
- 2-61 appropriate intermediate sites along the highway.
- 2-62 Sec. 225.198. TROOPER MARK JEFFREY PHEBUS MEMORIAL HIGHWAY.
- 2-63 (a) The portion of Farm-to-Market Road 1774 in Montgomery County
- 2-64 between its intersection with Misty Meadow Drive and its
- 2-65 intersection with Hunters Road is designated as the Trooper Mark
- 2-66 Jeffrey Phebus Memorial Highway. The designation is in addition to
- 2-67 any other designation.
- 2-68 (b) Subject to Section 225.021(c), the department shall:
- 2-69 (1) design and construct markers indicating the

3-1 designation as the Trooper Mark Jeffrey Phebus Memorial Highway and
3-2 any other appropriate information; and
3-3 (2) erect a marker at each end of the highway and at
3-4 appropriate intermediate sites along the highway.
3-5 Sec. 225.199. TROOPER DAVID IRVINE RUCKER MEMORIAL HIGHWAY.
3-6 (a) The portion of State Highway 100 in Cameron County between its
3-7 intersection with Farm-to-Market Road 523 and its intersection with
3-8 Farm-to-Market Road 3069 is designated as the Trooper David Irvine
3-9 Rucker Memorial Highway. The designation is in addition to any
3-10 other designation.
3-11 (b) Subject to Section 225.021(c), the department shall:
3-12 (1) design and construct markers indicating the
3-13 designation as the Trooper David Irvine Rucker Memorial Highway and
3-14 any other appropriate information; and
3-15 (2) erect a marker at each end of the highway and at
3-16 appropriate intermediate sites along the highway.
3-17 Sec. 225.200. TROOPER DANIEL HIGDON MEMORIAL HIGHWAY. (a)
3-18 The portion of Interstate Highway 20 in Smith County between mile
3-19 marker 571 and mile marker 575 is designated as the Trooper Daniel
3-20 Higdon Memorial Highway. The designation is in addition to any
3-21 other designation.
3-22 (b) Subject to Section 225.021(c), the department shall:
3-23 (1) design and construct markers indicating the
3-24 designation as the Trooper Daniel Higdon Memorial Highway and any
3-25 other appropriate information; and
3-26 (2) erect a marker at each end of the highway and at
3-27 appropriate intermediate sites along the highway.
3-28 SECTION 2. This Act takes effect September 1, 2021.
