- (1)promote the uniform judicial interpretation of all uniform laws; and

 $\underline{\text{(c)}}$ [(b)] The governor shall fill a vacancy by appointing a person to the commission for the unexpired term of the commissioner The governor shall fill a vacancy by appointing a vacating the office.

is prohibited from serving as a commissioner under (3) Section 329.004(d) [762.004(d)]; or

Sec. $\underline{329.008}$ [$\underline{762.009}$]. MEETING AND ELECTION OF OFFICERS. (a) The commission shall meet at least once every two years.

(b) The commissioners shall elect a chair [chairman] and secretary, who shall each hold office for a term of two years.

Sec. 329.009 [762.010]. COMPENSATION. A commissioner serves without compensation but is entitled to be reimbursed for reasonable expenses incurred in the performance of the commissioner's duties.

Sec. $\underline{329.010}$ [$\underline{762.011}$]. SUPPORT SERVICES. The Texas Legislative Council shall provide accounting, clerical, and other support services necessary for the commission to carry out its duties.

SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2021.
