 1-20 AN ACT

1-21 relating to the operation of golf carts in certain areas.
 1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
 1-23 SECTION 1. Section 551.403, Transportation Code, is amended
 1-24 to read as follows:
 1-25 Sec. 551.403. OPERATION AUTHORIZED IN CERTAIN AREAS. (a)
 1-26 An operator may operate a golf cart:
 1-27 (1) in a master planned community:
 1-28 (A) that is a residential subdivision as defined
 1-29 by Section 209.002(9), Property Code, or has in place a uniform set
 1-30 of restrictive covenants; and
 1-31 (B) for which a county or municipality has
 1-32 approved one or more plats ~~[a plat]~~;
 1-33 (2) on a public or private beach that is open to
 1-34 vehicular traffic; or
 1-35 (3) on a highway for which the posted speed limit is
 1-36 not more than 35 miles per hour, if the golf cart is operated:
 1-37 (A) during the daytime; and
 1-38 (B) not more than two miles from the location
 1-39 where the golf cart is usually parked and for transportation to or
 1-40 from a golf course.
 1-41 (b) Notwithstanding Section 551.402(b), a person may
 1-42 operate a golf cart in a master planned community described by
 1-43 Subsection (a) without a golf cart license plate on a highway for
 1-44 which the posted speed limit is not more than 35 miles per hour,
 1-45 including through an intersection of a highway for which the posted
 1-46 speed limit is more than 35 miles per hour.
 1-47 SECTION 2. Section 551.4031, Transportation Code, is
 1-48 amended to read as follows:
 1-49 Sec. 551.4031. PROHIBITION OF OPERATION ON HIGHWAY BY
 1-50 MUNICIPALITY, COUNTY, OR DEPARTMENT. (a) A county or municipality
 1-51 may prohibit the operation of a golf cart on a highway under Section
 1-52 551.403 ~~[551.404]~~ if the governing body of the county or
 1-53 municipality determines that the prohibition is necessary in the
 1-54 interest of safety.
 1-55 (b) The Texas Department of Transportation may prohibit the
 1-56 operation of a golf cart on a highway under Section 551.403
 1-57 ~~[551.404]~~ if the department determines that the prohibition is
 1-58 necessary in the interest of safety.
 1-59 SECTION 3. This Act takes effect immediately if it receives
 1-60 a vote of two-thirds of all the members elected to each house, as

2-1 provided by Section 39, Article III, Texas Constitution. If this
2-2 Act does not receive the vote necessary for immediate effect, this
2-3 Act takes effect September 1, 2021.
