(d) The University Interscholastic League may appoint a person to provide guidance on behalf of impacted stakeholders for purposes of Subsection (c)(5).

In maintaining the inclusive sports program, University Interscholastic League shall, to the greatest extent possible, require:

(1) students who participate in the inclusive sports program to be subject to the same rules and requirements as students who participate in other athletic programs offered by the league, including:

(A) grade and disciplinary requirements under Section 33.081(c); and

(B) requirements related to student safety in athletic activities under this chapter and Chapter 38; and

(2) team sports provided through the inclusive sports program to be organized similarly to other athletic programs offered by the league, including with respect to team practices, seasonal play, and local and statewide competitions.

(f) In addition to using funds available or appropriated for purpose, the University Interscholastic League or a partner affiliated with the league may seek and accept gifts, grants, or donations of money from public and private sources for the purpose of establishing or expanding the inclusive sports program.

SECTION 3. This Act takes effect September 1, 2021.
