1-19 A BILL TO BE ENTITLED
1-20 AN ACT

1-21 relating to the disclosure of certain information regarding the
1-22 occurrence of communicable diseases in residential facilities.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 81.046(b), Health and Safety Code, is
1-25 amended to read as follows:

1-26 (b) Reports, records, and information relating to cases or
1-27 suspected cases of diseases or health conditions are not public
1-28 information under Chapter 552, Government Code, and may not be
1-29 released or made public on subpoena or otherwise except as provided
1-30 by:

1-31 (1) Subsections (c), (c-1), (d), and (f); and
1-32 (2) Section 181.060.

1-33 SECTION 2. Subchapter B, Chapter 181, Health and Safety
1-34 Code, is amended by adding Section 181.060 to read as follows:

1-35 Sec. 181.060. INFORMATION REGARDING COMMUNICABLE DISEASES
1-36 IN CERTAIN FACILITIES. (a) In this section:

1-37 (1) "Communicable disease" has the meaning assigned by
1-38 Section 81.003.

1-39 (2) "Facility" means:
1-40 (A) a nursing facility licensed under Chapter

1-41 242;
1-42 (B) a continuing care facility licensed under

1-43 Chapter 246; and
1-44 (C) an assisted living facility licensed under

1-45 Chapter 247.

1-46 (3) "Resident" means an individual, including a
1-47 patient, who resides in a facility.

1-48 (b) In this chapter, protected health information does not
1-49 include information that identifies:

1-50 (1) the name or location of a facility in which
1-51 residents have been diagnosed with a communicable disease; or

1-52 (2) the number of residents who have been diagnosed
1-53 with a communicable disease in a facility.

1-54 (c) Unless made confidential under other law, the
1-55 information described by Subsection (b) is not confidential and is
1-56 subject to disclosure under Chapter 552, Government Code.

1-57 SECTION 3. This Act takes effect September 1, 2021.
