A BILL TO BE ENTITLED AN ACT

relating to the procedure for conducting surveys of public land, including the requirements regarding field notes and coordinate systems.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 21.041, Natural Resources Code, amended to read as follows:

Sec. 21.041. FIELD NOTES OF A SURVEY OF PUBLIC LAND. field notes of a survey of public land shall state:

(1)

- the county in which the land is located; the authority under which the survey is made and a (2) true description of the survey;
- (3) the land by proper field notes with the necessary calls and connections for identification, observing the Spanish measurement by varas;

(4) a diagram of the survey;

- the State Plane Coordinates based on the Texas (5) Coordinate System of 1927, [er] the Texas Coordinate System of 1983, or an alternative coordinate system adopted under Section 21.0711 values for the beginning point on the survey with appropriate reference to zone, mapping angle, grid distances, acreage and the N.G.S. Station to which the survey is tied;
  - (6) the names of the field survey personnel;
  - (7)the date the survey was made; and

(8) the signature of the surveyor. SECTION 2. Subchapter D, Chapter 21, Natural Resources Code, is amended by adding Section 21.0711 to read as follows:

Sec. 21.0711. ALTERNATIVE COORDINATE SYSTEMS. Texas Spatial Reference Center at Texas A&M University--Corpus Christi established under Section 88.503, Education Code, may adopt a revised state coordinate system that may be used for purposes of this subchapter under the authority granted to the center as the state's facilitator of the National Spatial Reference System.

(b) A revised coordinate system adopted under Subsection

is an official state coordinate system. SECTION 3. Section 21.077, Natural 21.077, Natural Resources Code, amended to read as follows:

Sec. 21.077. UNIT OF MEASUREMENT. The unit of measurement this subchapter has the following values, based on the in International Meter established by the National Bureau Standards:

one meter = 39.37 inches exactly;
