A BILL TO BE ENTITLED AN ACT

relating to the donation of food by public school campuses. 1-21

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 1-23 SECTION 1. Section 33.907, Education Code, is amended by amending Subsections (b), (c), and (d) and adding Subsection (c-1) 1-24 1-25 to read as follows:

1-26 (b) A school district or open-enrollment charter school may 1-27 1-28 allow a campus to elect to donate food to a nonprofit organization through a person [an official of the nonprofit organization] who is through a person [an officially of the hompforte organization] and is directly and officially affiliated with the campus, including a teacher or [-7] counselor, or through a parent of a student enrolled at the campus. The donated food may be received, stored, and distributed on the campus. Food donated by the campus may include: 1-29 1-30 1-31 1-32

1-33 (1) surplus food prepared for breakfast, lunch, or 1-34 dinner meals or <u>snacks</u> [a snack to be] served <u>from</u> [at] the campus 1-35 cafeteria, subject to any applicable local, state, and federal requirements; or (2) 1-36

(c) The type of food donated under <u>Subsection (b)(1)</u> [this 1-39 1-40 ction] may include:

(1) packaged [or unpackaged] unserved food that is packaged on the campus of a school district or open-enrollment charter school and has not been removed from the campus cafeteria; 1-41 is 1-42 1-43 (2) packaged served food if the packaging and food are 1 - 44

(3) whole, uncut produce; and (4)

wrapped raw <u>unserved</u> produce[; and

<u>unpeeled fruit required to be peeled before</u> [(-5)]consumption].

(c-1) Food that by law must be maintained at a certain temperature for safety may not be donated unless the campus has 1-50 1-51 maintained the food at the required temperature. (d) Food donated under this section 1-52

1-53 to a nonprofit 1-54 organization may be distributed at the campus at any time. Campus employees may assist in preparing and distributing the food as volunteers for the nonprofit organization. Each person who assists in the preparation and distribution of food as a volunteer must have 1-55 1-56 1-57 completed, or be supervised by a person who has completed, a basic food safety education or training program for food handlers accredited under Subchapter D, Chapter 438, Health and Safety Code. 1-58 1-59 1-60 SECTION 2.
