2-45 SECTION 3. Section 37.0832(f), Education Code, is repealed. 2-46 SECTION 4. This Act applies beginning with the 2021-2022 2-47 school year.

2-48 SECTION 5. This Act takes effect immediately if it receives 2-49 a vote of two-thirds of all the members elected to each house, as 2-50 provided by Section 39, Article III, Texas Constitution. If this 2-51 Act does not receive the vote necessary for immediate effect, this 2-52 Act takes effect September 1, 2021.
