## A BILL TO BE ENTITLED AN ACT

1-19 relating to the dissolution of the Angelina County Water Control and Improvement District No. 4. 1-20 1-21

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. (a) The directors of the Angelina County Water Control and Improvement District No. 4 shall wind up the affairs of 1-22 1-23 1-24 the district. 1-25

On the 60th day after the effective date of this Act: (b)

the Angelina County Water Control and Improvement (1) District No. 4 is dissolved;

the terms of the directors of the district expire; (2)

any remaining assets and liabilities of the 1-29 (3) district are transferred to the City of Diboll; and 1-30

1-31 (4) the territory of the district is added to the City 1-32 of Diboll Sewer CCN No. 20150.

1-33 SECTION 2. Effective on the 61st day after the effective of this Act, Chapter 1329, Acts of the 77th Legislature, 1-34 date Regular Session, 2001, is repealed. 1-35

SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, 1-36 1-37 1-38 1-39 officials, or entities to which they are required to be furnished 1-40 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 1-41 1-42 Government Code.

The governor, one of the required recipients, has the notice and Act to the Texas Commission on 1-43 (b) 1-44 submitted 1-45 Environmental Quality.

1-46 (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of 1-47 1-48 1-49 representatives within the required time.
