A BILL TO BE ENTITLED AN ACT

relating to student buildings fees at The University of Texas at Dallas.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. The heading to Section 54.531, Education Code, is amended to read as follows:

Sec. 54.531. STUDENT UNION BUILDINGS [BUILDING] FEES; THE UNIVERSITY OF TEXAS AT DALLAS.

SECTION 2. Section 54.531, Education Code, is amended by amending Subsection (a) and adding Subsections (a-1) and (a-2) to read as follows:

(a) The board of regents of The University of Texas System may levy a student union fee, not to exceed \$100 [\$60] per student for each regular semester and not to exceed  $\frac{$50}{}$  [\$40] per student for each term of the summer session, for the sole purpose of financing, constructing, operating, maintaining, and improving [a] student union <u>buildings</u> [building] for The University of Texas at Dallas.

 $\overline{(a-1)}$ The amount of the fee levied under this section may not be increased to an amount that exceeds by 10 percent or more the amount of the fee levied during the preceding academic year [+ provided, however, that the fee may not be increased above \$40 per student for each regular semester and \$26.67 per student for term of the summer session unless the increase is approved by a majority vote of [those] students enrolled at the university participating in a general student election held for that purpose.

SECTION 3. The heading to Section 54.5312, Education Code, is amended to read as follows:

Sec. 54.5312. STUDENT SERVICES BUILDINGS [BUILDING] FEE; THE UNIVERSITY OF TEXAS AT DALLAS.

SECTION 4. Section 54.5312(a), Education Code, is amended to read as follows:

(a) The board of regents of The University of Texas System may impose on each student enrolled at The University of Texas at Dallas a student services <u>buildings</u> [building] fee for the sole purpose of financing, constructing, operating, maintaining, and improving [a] student services <u>buildings</u> [building] at
