A BILL TO BE ENTITLED AN ACT

relating to the establishment and administration of the Texas 1-28 Aerospace Research and Space Economy Consortium and the Texas Space 1-29 Commission.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Chapter 61, Education Code, is amended by adding Subchapter V-1 to read as follows:

SUBCHAPTER V-1. TEXAS AEROSPACE RESEARCH AND SPACE ECONOMY

CONSORTIUM

1. DEFINITIONS. In this subchapter: "Consortium" means the Texas Aerospace Research 61.921.

and Space Economy Consortium.
(2) "Executive

committee" means the executive committee of the consortium.

Space Economy Consortium is established to:

Before assisting the executive committee as provided by this subsection, a member of the consortium must designate a liaison to the executive committee to represent that member.

- (2) research involving any aspect of space exploration and space flight;
- (3) workforce training to promote space exploration and space flight; and
- of 4-65 post-mission materials involved in curation 4-66 space exploration and space flight. 4-67
 - The following entities are eligible for a grant made (e) under this section:
 - (1) a business or nonprofit entity involved in the

space exploration, research, or aeronautics industry; and

(2) a governmental entity with which the commission has entered into an intergovernmental agreement for that purpose.

(f) The commission shall establish procedures for the administration and approval of grants made under this section, including procedures to ensure that a grant provided under this section is in the public interest and serves the public purpose of economic development and diversification.
