1-19 A BILL TO BE ENTITLED
 1-20 AN ACT

1-21 relating to the designation of portions of the state highway system
 1-22 as memorial highways for certain deceased peace officers.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 225.092(a), Transportation Code, is
 1-25 amended to read as follows:

1-26 (a) Notwithstanding Section 225.001(c), the portion of
 1-27 Business U.S. Highway 281-S in the municipal limits of Premont [281
 1-28 in Jim Wells County between its intersection with Farm-to-Market
 1-29 Road 716 and its intersection with County Road 422] is designated as
 1-30 the Lt. General Marc Cisneros Highway. The designation is in
 1-31 addition to any other designation.

1-32 SECTION 2. Subchapter B, Chapter 225, Transportation Code,
 1-33 is amended by adding Sections 225.217, 225.218, 225.219, 225.220,
 1-34 225.221, 225.222, 225.223, 225.224, and 225.225 to read as follows:

1-35 Sec. 225.217. TROOPER RUSSELL LYNN BOYD MEMORIAL HIGHWAY.

1-36 (a) The portion of U.S. Highway 290 in Waller County between its
 1-37 intersection with the Waller-Harris county line and its
 1-38 intersection with State Highway 6 is designated as the Trooper
 1-39 Russell Lynn Boyd Memorial Highway. The designation is in addition
 1-40 to any other designation.

1-41 (b) Subject to Section 225.021(c), the department shall:

1-42 (1) design and construct markers indicating the
 1-43 designation as the Trooper Russell Lynn Boyd Memorial Highway and
 1-44 any other appropriate information; and

1-45 (2) erect a marker at each end of the highway and at
 1-46 appropriate intermediate sites along the highway.

1-47 Sec. 225.218. RANGER STANLEY K. GUFFEY MEMORIAL HIGHWAY.

1-48 (a) The portion of U.S. Highway 87 in the municipal limits of Brady
 1-49 is designated as the Ranger Stanley K. Guffey Memorial Highway. The
 1-50 designation is in addition to any other designation.

1-51 (b) Subject to Section 225.021(c), the department shall:

1-52 (1) design and construct markers indicating the
 1-53 designation as the Ranger Stanley K. Guffey Memorial Highway and
 1-54 any other appropriate information; and

1-55 (2) erect a marker at each end of the highway and at
 1-56 appropriate intermediate sites along the highway.

1-57 Sec. 225.219. TROOPER MILTON ALEXANDER MEMORIAL HIGHWAY.

1-58 (a) The portion of Interstate Highway 35 in the municipal limits of
 1-59 Hillsboro is designated as the Trooper Milton Alexander Memorial
 1-60 Highway. The designation is in addition to any other designation.

2-1 (b) Subject to Section 225.021(c), the department shall:
2-2 (1) design and construct markers indicating the
2-3 designation as the Trooper Milton Alexander Memorial Highway and
2-4 any other appropriate information; and
2-5 (2) erect a marker at each end of the highway and at
2-6 appropriate intermediate sites along the highway.
2-7 Sec. 225.220. TROOPER ERNESTO ALANIS MEMORIAL HIGHWAY. (a)
2-8 The portion of Interstate Highway 2 in the municipal limits of
2-9 McAllen is designated as the Trooper Ernesto Alanis Memorial
2-10 Highway. The designation is in addition to any other designation.
2-11 (b) Subject to Section 225.021(c), the department shall:
2-12 (1) design and construct markers indicating the
2-13 designation as the Trooper Ernesto Alanis Memorial Highway and any
2-14 other appropriate information; and
2-15 (2) erect a marker at each end of the highway and at
2-16 appropriate intermediate sites along the highway.
2-17 Sec. 225.221. TROOPER HOLLIS S. LACY MEMORIAL HIGHWAY. (a)
2-18 The portion of U.S. Highway 377 in the municipal limits of Denton is
2-19 designated as the Trooper Hollis S. Lacy Memorial Highway. The
2-20 designation is in addition to any other designation.
2-21 (b) Subject to Section 225.021(c), the department shall:
2-22 (1) design and construct markers indicating the
2-23 designation as the Trooper Hollis S. Lacy Memorial Highway and any
2-24 other appropriate information; and
2-25 (2) erect a marker at each end of the highway and at
2-26 appropriate intermediate sites along the highway.
2-27 Sec. 225.222. TROOPER HOWARD JORDAN MEMORIAL HIGHWAY. (a)
2-28 The portion of U.S. Highway 67 in the municipal limits of Texarkana
2-29 is designated as the Trooper Howard Jordan Memorial Highway. The
2-30 designation is in addition to any other designation.
2-31 (b) Subject to Section 225.021(c), the department shall:
2-32 (1) design and construct markers indicating the
2-33 designation as the Trooper Howard Jordan Memorial Highway and any
2-34 other appropriate information; and
2-35 (2) erect a marker at each end of the highway and at
2-36 appropriate intermediate sites along the highway.
2-37 Sec. 225.223. TROOPER MARK FREDERICK MEMORIAL HIGHWAY. (a)
2-38 The portion of Interstate Highway 10 in Austin County between its
2-39 intersection with the Austin-Waller county line and its
2-40 intersection with State Highway 36 is designated as the Trooper
2-41 Mark Frederick Memorial Highway. The designation is in addition to
2-42 any other designation.
2-43 (b) Subject to Section 225.021(c), the department shall:
2-44 (1) design and construct markers indicating the
2-45 designation as the Trooper Mark Frederick Memorial Highway and any
2-46 other appropriate information; and
2-47 (2) erect a marker at each end of the highway and at
2-48 appropriate intermediate sites along the highway.
2-49 Sec. 225.224. TROOPER WILLIAM KOHLLEPPEL III MEMORIAL
2-50 HIGHWAY. (a) The portion of Interstate Highway 10 in Austin County
2-51 between its intersection with State Highway 36 and its intersection
2-52 with the Austin-Colorado county line is designated as the Trooper
2-53 William Kohlleppele III Memorial Highway. The designation is in
2-54 addition to any other designation.
2-55 (b) Subject to Section 225.021(c), the department shall:
2-56 (1) design and construct markers indicating the
2-57 designation as the Trooper William Kohlleppele III Memorial Highway
2-58 and any other appropriate information; and
2-59 (2) erect a marker at each end of the highway and at
2-60 appropriate intermediate sites along the highway.
2-61 Sec. 225.225. TROOPER BILLY D. HOWRY MEMORIAL HIGHWAY. (a)
2-62 The portion of Interstate Highway 35 in Williamson County between
2-63 mile marker 268 and mile marker 272 is designated as the Trooper
2-64 Billy D. Howry Memorial Highway. The designation is in addition to
2-65 any other designation.
2-66 (b) Subject to Section 225.021(c), the department shall:
2-67 (1) design and construct markers indicating the
2-68 designation as the Trooper Billy D. Howry Memorial Highway and any
2-69 other appropriate information; and

3-1 (2) erect a marker at each end of the highway and at
3-2 appropriate intermediate sites along the highway.

3-3 SECTION 3. This Act takes effect September 1, 2023.
