BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter C, Chapter 37, Education Code, is amended by adding Section 37.0818 to read as follows:

Sec. 37.0818. PRIVATE SCHOOL PEACE OFFICERS. (a) This section applies only to a private school that has an enrollment of at least 1,500 students.

(b) The governing body of a private school to which this section applies may commission peace officers to enforce state and local law on a campus of the school.

(c) A peace officer commissioned by a private school under this section must meet all minimum standards for peace officers established by the Texas Commission on Law Enforcement.

SECTION 2. Article 2.12, Code of Criminal Procedure, is amended to read as follows:

 $\,$ Art. 2.12. WHO ARE PEACE OFFICERS. The following are peace officers:

- (5) investigators of the district attorneys', criminal district attorneys', and county attorneys' offices;
- (6) law enforcement agents of the Texas Alcoholic Beverage Commission;
