SUBCHAPTER C. POWERS AND DUTIES

Sec. 8026A. 0301. GENERAL POWERS AND DUTIES. The district has the powers and duties necessary to accomplish the purposes for which the district is created.

Sec. 8026A.0302. MUNICIPAL UTILITY DISTRICT POWERS DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59, Article XVI, Texas Constitution.

Sec. 8026A.0303. AUTHORITY FOR ROAD PROJECTS. Section 52, Article III, Texas Constitution, the district may design, acquire, construct, finance, issue bonds for, improve, operate, maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads.

Sec. 8026A.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial

jurisdiction the road project is located.

(b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, subdivision requirements, and regulations of each county in which

the road project is located.

(c) If the state will maintain and operate the road,

Texas Transportation Commission must approve the plans specifications of the road project.

Sec. 8026A.0305. DIVISION OF DISTRICT. (a) The board, on its own motion or on receipt of a petition signed by the owner or owners of a majority of the assessed value of the real property in the district, may adopt an order dividing the district.

(b) An order dividing a district may create one or more new districts and may provide for the continuation of the district.

An order dividing the district shall: (c)

(1) name any new district;
(2) include the metes and bounds description of the territory of each of the districts;

(3) appoint temporary directors for any new district;

(4) provide for the division of assets and liabilities between the districts.

(d) The board may adopt an order dividing the district

before or after the date the board holds an election to confirm the district's creation.

(e) The district may be divided only if the district:

- A new district created by the division of the district may not, at the time the new district is created, contain any land outside the territory of the district as it existed on January 1,
- On or before the 30th day after the date of adoption of an order dividing the district, the district shall file the order with the commission and record the order in the real property records of each county in which the district is located.

 Sec. 8026A.0401. AUTHORITY TO ISSUE BONDS AND OTHER

 OBLIGATIONS FOR ROAD PROJECTS. (a) The district may issue bonds or other obligations payable wholly or partly from ad valorem taxes, revenue, contract payments, grants, or other district money, or any combination of those sources, to pay for a road project authorized
- by Section 8026A.0303.

 (b) The district may not issue bonds payable from ad valorem taxes to finance a road project unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an election held for that purpose.
- (c) At the time of issuance, the total principal amount of or other obligations issued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the district.
- Sec. 8026A.0402. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner provided by Sections 54.601 and 54.602, Water Code.

 SECTION 2. The Twinwood Municipal Utility District No. 1
- retains all the rights, powers, privileges, authority, duties, and functions that it had before the effective date of this Act.
- SECTION 3. (a) The legislature validates and confirms all governmental acts and proceedings of the Twinwood Municipal Utility District No. 1 that were taken before the effective date of this
- This section does not apply to any matter that on the (b) effective date of this Act:
- (1) is involved in litigation if the litigation ultimately results in the matter being held invalid by a final court judgment; or
 - (2) has been held invalid by a final court judgment.
